

Introduction

I created ProFellow's *Directory of Fully Funded Graduate Programs and Full Funding Awards* to provide you an overview of the wide variety of funding options available to you across programs in more than 60 disciplines. My goal is to show you the abundance of full funding opportunities that are out there and provide you resources to achieve a high-quality master or doctoral degree debt-free!

"Full funding" is an award that covers your full tuition expenses and provides a monthly stipend for living expenses for the duration of your graduate studies. Full funding can be offered by the university you are accepted to, or through a nationally competitive award sponsored by a foundation, research group, agency or corporation. Sometimes "full funding" is offered to top applicants with no strings attached. In most cases, "full funding" from the university will come in the form of a Graduate Teaching or Research Assistantship (also called Studentship or Instructorship). Assistantships are part-time employment positions with the university that are exclusively filled by graduate students. The responsibilities of an Assistantship are complementary to your research and studies and provide you invaluable experience for your resume.

Full funding from the university is typically offered to both domestic and international students.

There are more than 1,000 fully funded graduate programs and full funding awards listed here, but please note, this list is not exhaustive.

There are *many more* fully funded programs like these out there. Through your own research, you can find more fully funded graduate programs like these that will provide you the academic foundation you need to achieve your career goals.

Fully Funded Ph.D. Programs

The following lists include universities that offer fully funded Ph.D. programs across more than 40 disciplines in the U.S., Canada and Europe. To learn more about each university, the Ph.D. program on offer, and the program's application and eligibility guidelines, please click the university name to be directed to the program's webpage for more details.

You'll find that the eligibility requirements and application instructions vary widely from program to program, so compare programs carefully and be sure to reach out to the Admissions Office or Head of the School or Department when you have questions.

You'll notice that some programs offer funding for five to six years, while some programs only guarantee three years of funding. Typically if a program guarantees funding for the first three years, you will be able to achieve funding for years four through six. Many universities only guarantee funding for the first three years because they encourage students to seek outside sources of funding for their dissertation research through external fellowships and grants.

Note: The information on any of the stipend amounts listed here may be outdated! Stipend amounts change often. Be sure to confirm stipend amounts on the university website or through an inquiry to Admissions.

Fully Funded Ph.D. Programs in Accounting

Bentley University (Waltham, MA): All Ph.D. students receive a full tuition scholarship and individual student health insurance. All fellowship packages include a stipend to assist with living expenses. Fellowships typically range from \$30,000-\$36,000 per year.

Ohio State University, Fisher College of Business (Columbus, OH): All admitted students into any of the Fisher Ph.D. programs are fully funded, including a stipend and tuition costs. The funding may come in the form of fellowships, research assistantships, teaching assistantships, supplemental grants, etc.

Rice University, Jones School of Graduate Business (Houston, TX): Full financial assistance and a stipend of \$40,000 will be offered to each admitted student in the Ph.D. program in the form of a research assistantship, where the student must work as a research assistant for assigned faculty members.

University of Chicago, Booth School of Business (Chicago, IL): All qualified students who are admitted to the Ph.D. program are awarded financial assistance consisting of a tuition grant, stipend support of \$42,500 per year, health insurance (basic plan for a single student only), and a computer or computer subsidy.

University of Michigan, Ross School of Business (Ann Arbor, MI): Michigan Ross provides full funding to all students admitted to the doctoral program. Five years of funding are provided, which includes a full tuition waiver, health insurance, and a generous stipend package that combines both fellowship funding and a graduate assistantship.

University of Pennsylvania, Wharton School of Business (Philadelphia, PA): All admitted Wharton doctoral students receive a fellowship that covers the cost of tuition and health insurance, and provides a stipend. It is expected that a similar level of financial aid may be awarded for up to 5 years. All financial aid awards are contingent upon a student's satisfactory academic progress.

University of Southern California, Marshall School of Business (Los Angeles, CA): Accepted students receive a package that includes a full tuition waiver, generous stipend, individual health and dental insurance, and coverage of mandatory student health center fees. The total financial support provided is approximately \$60-70K per year, depending on a student's course-load.

Fully Funded Ph.D. Programs in African American and Africana Studies

University of Pennsylvania (Philadelphia, PA): All applicants will automatically be considered for fellowship awards. All students in good standing are provided full tuition and living stipends.

Brown University (Providence, RI): The Graduate School offers incoming doctoral students five years of guaranteed financial support, including a stipend, tuition remission, a health-services fee, and health- and dental-insurance subsidies. Financial aid for master's students is determined within each program.

Cornell University Graduate School (Ithaca, NY): The Graduate School supports 97% of on-campus students in research Ph.D. programs through funding packages that include tuition, fees, health insurance, and a living allowance or stipend.

Harvard University (Cambridge, MA): Our financial aid program features guaranteed funding for the first five years to all Ph.D. students, and a variety of funding options and fellowships to other students.

Northwestern University (Evanston, IL): Students admitted to the Ph.D. program typically receive five years of funding, including a fellowship in the first year and teaching and research fellowships or departmental assistantships in subsequent years. Students will also receive summer support for five years. Fellowships and assistantships cover the full cost of tuition and provide a stipend.

Ohio State University (Columbus, OH): In addition to university-wide fellowships awarded directly by the Graduate School on a competitive basis, the Department offers financial support to graduate students in the form of teaching associateships (TA), research associateships (RA) or administrative associateships (AA).

Penn State University (State College, PA): All graduate students in good standing receive full financial support for five years. Students in our programs usually work as teaching assistants. The program also supports participation in academic conferences and provides funds for summer study and research.

University of Texas at Austin (Austin, TX): Ph.D. candidates are automatically considered for funding during the graduate admissions process; no separate fellowship application is required. A typical award includes a combination of university and department fellowships, and teaching and graduate research assistantships.

University of Wisconsin-Milwaukee (Milwaukee, WI): The Department of African and African Diaspora Studies is able to guarantee 3-4 years of funding for students in the Ph.D. Program. Most admitted Ph.D. students are funded via academic-year Teaching Assistantships, which require approximately 20 hours of work per week. In addition to their stipends (approximately \$13,750 per academic year for a teaching assistant), these appointments include full remission of tuition (both in-state and out-of-state tuition), as well as benefits such as low-cost health insurance.

Yale University (New Haven, CT): Ph.D. students at Yale are normally fully-funded for a minimum of five years. During that time, our students receive a twelve-month stipend to cover living expenses and a fellowship that covers the full cost of tuition.

Fully Funded Ph.D. Programs in Architecture

A. Alfred Taubman College of Architecture and Urban Planning (Ann Arbor, MI): Ph.D. in Architecture is committed to funding each admitted student for four years of the expected time to complete the degree, including an annual stipend, full tuition, and health care during the academic year (Sept–April). Additional years of funding may be available through graduate student instructorships, research assistantships, and other sources.

Massachusetts Institute of Technology (Boston, MA): In general, Ph.D. students are funded on financial aid packages that consist of a Teaching Assistantship (TA) or Research Assistantship (RA) salary component, plus a tuition component. TA or RA assignments are made by the faculty Discipline Group Director at the beginning of each term.

Princeton University (Princeton, NJ): Princeton guarantees funding for its regularly enrolled, degree-seeking Ph.D. candidates for all years of regular program enrollment, contingent upon satisfactory academic performance. The defined Ph.D. program length is generally five years. Princeton provides a minimum level of annual support that includes full tuition and fees support and a base stipend amount. This base stipend is intended to support the estimated living expenses of a single graduate student during each year of regular enrollment.

Swiss Federal Institute of Technology (Zurich, Switzerland): 100% is the standard employment of doctoral students at ETH. The salary should be high enough to fully support you for the time of employment. Individual adjustments will take into account professional experience, children etc. Generally, doctoral students should devote their full working time to their Ph.D. research. However, if desired, they may assist in teaching one or two courses during their appointment.

Oslo School of Architecture and Design (Oslo, Norway): AHO usually has an intake of four internally funded Ph.D. candidates per year. AHO offers three-year stipends with a possible extra year of institutional commitment.

University of Maryland (College Park, MD): The School of Architecture, Planning and Preservation anticipates approximately three research assistantships available to students in the Ph.D. Program in Urban and Regional Planning and Design each year. Students may also find financial support on faculty research projects and with teaching possibilities in our master's programs. Compensation for assistantships include tuition remission for up to 10 credit hours per semester, plus a stipend.

Fully Funded Ph.D. Programs in Anthropology

Boston University (Boston, MA): Each year, The Boston University Graduate School of Arts and Sciences offers incoming Ph.D., students Dean's Fellowships, which include full tuition, a living stipend, and health insurance for five years.

Brown University (Providence, RI): The Graduate School offers incoming doctoral students five years of guaranteed financial support, including a stipend, tuition remission, health services fee, and health and dental insurance subsidies.

Duke University (Durham, NC): Graduate Fellowships provide tuition plus a living stipend for five years, contingent on continued appropriate progress toward the Ph.D. degree. Stipends and fellowships require service in the form of teaching assistance. Other university awards are given on a competitive basis to outstanding students. These include the James B. Duke Fellowships, International Fellowships, and Deans' Fellowships.

Emory University (Atlanta, GA): The Department of Anthropology funds all its graduate students and keeps its class size small to maximize financial support and faculty responsiveness to the needs of each student. Anthropology Graduate Fellowships cover tuition costs and afford an additional 12-month living stipend of at least \$31,000/year for five years, pending satisfactory progress.

Harvard University (Cambridge, MA): The financial aid for the Ph.D. in Anthropology features guaranteed funding for the first five years to all Ph.D. students, and a variety of funding options and fellowships to other students.

City University of New York (New York, NY): Beginning in Fall 2013, all students admitted to the Anthropology Doctoral Program will receive full tuition fellowships for five years of study. U.S. citizens and permanent residents are required to establish New York State residency to maintain full fellowship coverage in years 2-5. Many students will also receive Graduate Center Fellowships (GCFs) that include stipend/research support of \$25,000 annually.

University of California – San Diego (San Diego, CA): Graduate students receive financial support for up to eight years. A portion of the stipend/salary will be paid through an academic student employment (ASE) which includes graduate student researchers (GSRs), teaching assistants (TAs) or readers for an undergraduate course. Each of these employments covers tuition, graduate student health insurance (GSHIP) and has a monthly salary. The remainder of financial support will be in the form of a Research Fellowship to work on a research project of their own.

University of Kansas (Lawrence, KS): KU Anthropology is committed to providing four-year funding packages to admitted graduate students. The majority of departmental funding for graduate students in anthropology comes in the form of Graduate Teaching Assistant (GTA) and Graduate Research Assistant (GRA) positions. GTA and GRA positions include a full tuition waiver and health insurance with KU paying 75% of the premium.

University of Minnesota (Minneapolis, MN): All students admitted to the Ph.D. program are offered a five-year funding package, contingent on satisfactory progress toward the degree. The funding package provides payment of tuition up to 14 credits per semester, partial payment of the health insurance premium, and a stipend.

University of Pennsylvania (Philadelphia, PA): All accepted full-time Ph.D. applicants are offered the Benjamin Franklin Fellowship which includes the cost of tuition, fees and health insurance as well as providing an annual stipend.

University of Virginia (Charlottesville, VA): All incoming students for the Ph.D. are supported with a five-year funding package as well as additional grants for foreign language study, conference travel, and preparatory research during summers.

Fully Funded Ph.D. Programs in Biomedical Engineering

Cornell University (Ithaca, NY): Since the BME Department was founded in 2004, all Ph.D. students have been fully funded, i.e., tuition, stipend, and health insurance, throughout their degree program.

Duke University (Durham, NC): Most applicants admitted to the Ph.D. program are offered a fellowship or research assistantship. Financial support awarded to Ph.D. students includes a stipend, tuition payments and payments for most Graduate School fees.

Johns Hopkins University (Baltimore, MD): All students are admitted with a full fellowship that covers tuition, and provides a modest stipend for the duration of their Ph.D.. Because students are fully funded, they can choose to perform their dissertation in essentially any laboratory in the University.

University of Michigan (Ann Arbor, MI): All successful BME Ph.D. students are fully supported by their research advisors, through external or internal fellowships, or as graduate student instructors.

University of Pennsylvania (Philadelphia, PA): If accepted as a Ph.D. student in Bioengineering, full funding will be provided that includes tuition, health insurance, and a stipend.

Stanford University (Stanford, CA): All students admitted to the Ph.D. program are fully funded for five years; this covers all tuition plus a quarterly living stipend. For 2018-19, the living stipend is \$10,300 per quarter.

University of Texas at Austin (Austin, TX): All admitted Ph.D. students receive full financial support through graduate research assistant positions, fellowships, and teaching assistant positions. This includes a competitive annual stipend, paid tuition and fees, and health insurance coverage for the duration of the student's degree program.

University of Virginia (Charlottesville, VA): All doctoral students are fully funded, and 40% also receive additional fellowships and grants.

Fully Funded Ph.D. Programs in Biology

Arizona State University (Tempe, AZ): We guarantee 5 years of academic-year funding as a teaching or research assistant. This includes a stipend, insurance and tuition support to cover the required 84 hours for the degree.

Boston University (Boston, MA): Students receive full tuition coverage, fees, health insurance options, and a \$35,000 stipend per year.

Duke University (Durham, NC): The Graduate School expects that Ph.D. students will be financially supported for the majority of the time they are registered and working toward their degree. Generally speaking, Ph.D. students should receive payment of tuition, a stipend, and fee support for a minimum of five years, as well as health insurance for six years.

Harvard University (Boston, MA): All students admitted to the Ph.D. in biological sciences in public health program, including international students, are guaranteed full funding, which includes a stipend, tuition, and health insurance for five years, provided they maintain satisfactory progress.

Massachusetts Institute of Technology (Cambridge, MA): All graduate students receive full-tuition coverage, a stipend to cover living expenses, and Individual Health Insurance.

Mayo Clinic College of Medicine & Science (Rochester, MN): Our Ph.D. Program in biomedical science includes an annual graduate-level stipend, full tuition and travel expenses to scientific meetings provided by mentors.

University of California Irvine (Irvine, CA): Students admitted to the doctoral programs in the School of Biological Sciences are offered full financial support as long as they are making satisfactory progress including a generous stipend, fees, non-resident tuition and health insurance.

University of Pittsburgh (Pittsburgh, PA): As of Fall 2019, the normal level of support is \$29,520/ year; the stipend amount typically increases by about 3-5% each year. The University of Pittsburgh provides excellent health insurance options and tuition waivers.

University of Rochester (Rochester, NY): The Program is fully funded with tuition fellowship, competitive stipend and health insurance.

University of Southern California (Los Angeles, CA): Ph.D. students receive full funding throughout their studies, including stipend, health and dental benefits.

University of Utah (Salt Lake City, UT): Doctoral students are guaranteed five years of stipend support at \$28,000/year through a combination of research assistantships, training grants, and teaching assistantships. In addition to the annual stipend, support for doctoral students includes tuition and health insurance.

Van Andel Institute Graduate School (Grand Rapids, MI): Students in the doctoral program at the Graduate School are supported by institutional (internal) fellowships for five years. These fellowships include a stipend of approximately \$35,000 per year and health, dental and vision insurance for the student (and family). The Graduate School also provides a laptop computer and up to \$2,000 per year to attend scientific conferences.

Fully Funded Ph.D. Programs in Business and Entrepreneurship

Bentley University (Waltham, MA): All Doctoral Fellows receive a full tuition scholarship and individual student health insurance. Fellowship packages typically range from \$30,000-\$36,000 per year. Funding is guaranteed for four years, with a fifth year contingent upon progress in the program.

Duke University Fuqua School of Business (Durham, NC): Fuqua offers fellowships to all doctoral students, including international students. This fellowship pays for tuition, a competitive stipend for living expenses, and single-person health fees. The fellowship is renewable for up to five years of doctoral education, conditional on good academic standing in the program.

Erasmus Research Institute of Management (Rotterdam, Netherlands): Our Ph.D. projects are fully funded and salaried positions. Starting monthly salary is €2,325 in the first year, €2,709 in the second year, €2,835 in the third year, and €2,972 in the fourth year (all mentioned figures are gross and fixed amounts).

Grenoble Ecole de Management (Grenoble, France): Our experimental lab is equipped with state-of-the-art equipment, and the generous support provided for Ph.D. students' attendance at conferences and doctoral consortia provide our students with the backing they need to succeed. Our doctoral students are fully funded, thanks to tuition waivers and assistantships.

IESE Business School University of Navarra (Pamplona, Spain): All admitted students will be fully financially supported. The financial support package includes the annual tuition fees of 30.000€ and a yearly stipend to cover living expenses of 16.695€. This aid is renewable upon satisfactory progress in the program for up to 5 years.

Imperial College Business School (London, United Kingdom): We offer a fully funded Doctoral programme at the Business School. This includes a full tuition fee waiver (Home/EU or Overseas fees) plus a living stipend for up to five years through the Business School Graduate Teaching Assistant Scholarship.

London Business School (London, United Kingdom): All students offered a place on the Ph.D. programme receive full funding, which includes a tuition fee waiver and a stipend guaranteed for five years.

MIT Sloan School of Management (Cambridge, MA): Students receive full academic year tuition plus a monthly stipend of \$3,630 for each of 12 months per year (annual total of \$43,560). Student medical insurance, a new laptop computer at the beginning of the first and fourth years, and a \$4,500 conference travel budget is allocated over 5 years in the program.

Ohio State University Fisher College of Business (Columbus, OH): Entering doctoral students can receive a Graduate Assistant (GA) Fellowship that covers tuition, insurance and a monthly stipend. Students continuing in the doctoral program are eligible for reappointment based upon funding availability and the most recent annual and periodic student performance evaluations. It is normally expected that students who exhibit acceptable progress in the program will be given such support for a period of five academic years.

Rice University Jones Graduate School of Business (Houston, TX): Admitted students will be offered stipend support of \$40,000 per fiscal year. This stipend is available for each year of full-time study, conditional on satisfactory progress in the doctoral program.

University of Pittsburgh Katz Graduate School of Business (Pittsburgh, PA): The Ph.D. program provides a five-year financial aid package. Currently, the financial aid package includes a stipend of \$27,590 and full tuition remission for five years and comprehensive health insurance to both domestic and international students.

Fully Funded Ph.D. Programs in Chemical Engineering

Colorado State University (Fort Collins, CO): Applicants admitted to the PhD program are supported with a competitive stipend and full tuition.

Cornell University (Ithaca, NY): Complete financial support for 5 years is provided for students in the PhD program. This support includes a stipend, a full tuition award, and health insurance. Financial support comes in the form of teaching assistantships, graduate research assistantships, research fellowships, etc.

Imperial College London (London, United Kingdom): The Department of Chemical Engineering has a number of fully-funded scholarships available for outstanding PhD applicants. A number of research council-funded studentships are also available to eligible students. Other sources of financial support for PhD students include bursaries and research assistantships funded by industry or the European Union.

McGill University (Quebec, Canada): All PhD students assemble funding through scholarships, fellowships, stipends and other funding opportunities through their research supervisor.

University of Michigan (Ann Arbor, MI): Students receive a guarantee of full funding at the point of admission and throughout the duration of their four-or-five-year program. This comprehensive package includes tuition, fees, University health insurance and a monthly stipend.

University of Pennsylvania (Philadelphia, PA): Students accepted as PhD students in Chemical and Biomolecular Engineering are customarily "fully funded," which means that funding will be provided that includes tuition, health insurance, and a stipend.

Western University (Ontario, Canada): Chemical & Biochemical Engineering offers financial support for eligible graduate students through research grants, contracts, scholarships and teaching assistantships. Funding is provided for full-time students for the first four years of the PhD program.

Yale University (New Haven, CT): All admitted PhD students receive full tuition and fee waiver, a generous stipend, and health insurance.

Fully Funded Ph.D. Programs in Chemistry

University of Alabama at Birmingham (Birmingham, AL): Chemistry students in the Ph.D. program are supported by a graduate teaching assistantship including a competitive monthly stipend in addition to a tuition scholarship covering full tuition and fees.

University of California Los Angeles (Los Angeles, CA): The Department funds tuition, student fees, health insurance, and an annual stipend for living expenses for students enrolled in the program. As a part of the doctoral program, graduate students are required to serve as a Teaching Assistant for a minimum of three academic quarters.

Notre Dame University (Notre Dame, IN): Chemistry students have been very successful in securing many of the University Fellowships that are available during the application process. Successful applicants receive full-tuition scholarships that include all fees and a stipend of \$25,614 – \$32,544.

Pennsylvania State University (State College, PA): The most common form of graduate support, teaching and research assistantships, include a stipend, tuition remission, and a subsidy for medical insurance. Fellowships without teaching assistantships are also available.

Princeton University (Princeton, NJ): All students receive full financial support for the length of their course of study funded through fellowship, teaching and advisor support. This support is not a loan and does not require repayment. Students are provided tuition, health insurance and a stipend for housing and living expenses.

Purdue University (West Lafayette, IN): Incoming Ph.D. students receive financial support for a period up to 5 years from the date of admission. In exchange for this support, students participate as teaching assistants (TAs) at both undergraduate and graduate levels. Fellowships and faculty awards are also available.

Rutgers University (New Brunswick, NJ): Financial support is guaranteed for all Ph.D. candidates in good academic standing, and may come from a variety of sources including research assistantships, teaching assistantships and a variety of fellowships

Stanford University (Stanford, CA): The Chemistry Department is committed to providing salary/ stipend and tuition for Chemistry Ph.D. students who are in good academic standing, working for chemistry professors. Chemistry students receive support from three different sources: Teaching Assistantships (TA), Research Assistantships (RA), and fellowships.

Fully Funded Ph.D. Programs in Cinema and Media Studies

Cornell University (Ithaca, New York): All Ph.D. degree candidates are guaranteed four years of funding (including a stipend, a full tuition fellowship, and student health insurance) and also summer support for four years.

Harvard University (Cambridge, MA): Harvard guarantees full financial support to Ph.D. students—including tuition, health fees, and basic living expenses—for a minimum of five years. This multi-year funding package includes a combination of tuition grants, stipends, traineeships, teaching fellowships, research assistantships, and other academic appointments.

University of British Columbia (UBC) (Vancouver, BC, Canada): Applicants to UBC have access to a variety of funding options, including merit-based and need-based opportunities. A funding package of at least \$18,000 for each of the first four years of their Ph.D..

University of Chicago (Chicago, IL): Doctoral students will be guaranteed to have funding support from the University of Chicago, external sources, or a combination of the two for the duration of their program to include the full tuition coverage, annual stipend and fully paid individual annual health insurance premiums. The stipend and teaching remuneration was \$27,000 over nine months. Additional summer funds of \$4,000 were available every year in the program.

University of Southern California (Los Angeles, CA): Graduate funding packages (fellowships and teaching assistantships) are tailored to the needs of the individual. The Cinema & Media Studies department will contact admitted students regarding funding information and offers once admission decisions are announced. Scholarships are open to both domestic and international students.

University of Toronto (Toronto, ON): The Cinema Studies Institute provides base funding for all graduate students enrolled in a four-year Ph.D. program. It will include tuition and fees, and \$17,500. The base funding may include income from a variety of sources including external awards.

York University (Toronto, Ontario): Domestic Ph.D. students receive more than \$23,000/year along with healthcare benefits and other forms of research support. In recent years, most Cinema & Media Studies (CMS) Ph.D. students have received additional funding through awards.

Fully Funded Ph.D. Programs in Civil Engineering

Carnegie Mellon University (Pittsburg, PA): Many of our graduate students conducting research in the department receive financial aid in the form of research assistantships that cover tuition, technology fees, and a stipend for living expenses for the calendar year (including Summer) up to five years, as long as sufficient progress is made toward degree completion.

John Hopkins Whiting School of Engineering (Baltimore, MD): All Ph.D. students are fully funded with tuition, a stipend, and benefits (including healthcare) for the entire duration of the program.

Northwestern University (Evanston, IL): All Ph.D. students are fully funded throughout the duration of their studies by a combination of internal and external fellowships, grants, and teaching and research assistantships. The Department of Civil and Environmental Engineering offers a substantial number of academic quarters of fellowship and assistantship support for outstanding Ph.D. degree applicants.

Stanford University (Stanford, CA): All Ph.D. students who are in good standing relative to their Ph.D. program requirements are funded to the department's Ph.D. standard. In all departments, this is at least equivalent to Stanford's 20-hour-RA salary plus tuition to cover the department's required enrollment (summer enrollment requirements vary by department).

Texas A&M University (College Station, TX): The Zachry Department of Civil and Environmental Engineering is offering multiple fully supported fellowships for graduate students who want to pursue doctoral degrees. These four-year fellowships will include tuition, fees, stipend, and professional development opportunities.

University of Michigan (Ann Arbor, MI): All Michigan Engineering doctoral students are guaranteed full funding, provided they continue to meet all the milestones on the path to their doctorate. The package includes tuition and fees, University Health Insurance, and a monthly living stipend.

University of Toronto (Toronto, Ontario): Ph.D. students receive 4 years of funding for their Ph.D. program This includes a stipend, tuition and fees. Packages are made up of Scholarships, Fellowships, and Research Assistantships (RA).

University of Virginia (Charlottesville, VA): All full-time doctoral students at the UVA School of Engineering and Applied Science are fully funded. Typical funding sources include research and teaching assistantships, external fellowships, and School or program fellowships.

University of Washington (Seattle, WA): Ph.D. students are fully funded with research or teaching assistantships, departmental support, and fellowships from a variety of organizations, such as the National Science Foundation, Achievement Rewards for College Scientists, and many more.

Fully Funded Ph.D. Programs in Classics

Columbia University (New York, NY): All Classics doctoral students receive a full funding package, which includes both the cost of tuition and a stipend.

Harvard University (Cambridge, MA): Funding for the duration of graduate study is normally provided by outright fellowship grants in the first two years, by a dissertation completion fellowship in the final year, and by a combination of tuition grants and teaching fellowships in the intervening years. Candidates who have successfully completed their General Examinations are normally assigned teaching fellowships in undergraduate courses, which include elementary language courses, sophomore and junior tutorials, literature surveys, and courses taught in translation. Teaching is guaranteed in the third and fourth year.

Princeton University (Princeton, NJ): Princeton guarantees funding for its regularly enrolled, degree-seeking Ph.D. candidates for all years of regular program enrollment, contingent upon satisfactory academic performance. This base stipend is intended to support the estimated living expenses of a single graduate student during each year of regular enrollment.

Rutgers University (New Brunswick, NJ): Rutgers Classics offers a number of funding options to Ph.D. students. The standard package is five years, with a fellowship stipend for the first, third, and last years, and a teaching assistantship for the second and fourth years. In addition, advanced students may be given the opportunity to teach as a part-time lecturer in the undergraduate curriculum or at neighboring institutions.

Stanford University (Stanford, CA): The department offers all admitted students a comprehensive funding package covering tuition, stipend, research support, and teaching. Our goal is to support students as fully as possible in their development as both scholars and teachers. Generous summer and conference travel funds are also available. The program has an excellent placement record.

University of Chicago (Chicago, IL): Incoming doctoral students receive a comprehensive 6-year funding package to support them in their scholarly and pedagogical training and are eligible to be registered for up to 8 years. The 6-year funding package includes: an academic year stipend (and teaching remuneration), 5 summer stipends, full tuition aid and health insurance premium aid. Renewal of this award is contingent on satisfactory academic progress. Students are expected to reach candidacy by the start of year 5 to remain in the program.

University of North Carolina – Chapel Hill (Chapel Hill, NC): It is the policy of the Department of Classics not to admit students to its graduate programs without funding, although exceptions may be made in very particular circumstances. Although the available fellowships and assistantships vary to some extent in the level of support they provide, they all include a stipend, eligibility for full tuition, and health insurance. With only a few exceptions, they all also involve service as a Graduate Teaching Assistant (GTA).

Yale University (New Haven, CT): For doctoral students in the humanities, Yale offers a full funding package for all incoming Ph.D. students for a minimum of five years, with most students in FAS programs eligible for a sixth year of funding. The basic package includes full tuition and generous annual stipend. In 2018-2019, Yale's minimum stipend is \$31,000. Generous sixth-year funding and teaching opportunities are available to those who are solidly on track to complete their dissertation by the summer after sixth year.

Fully Funded Ph.D. Programs in Clinical Psychology

Arizona State University (Tempe, AZ): The Department of Psychology typically pays ASU tuition for full-time doctoral students with 20 hour-per-week graduate teaching or research assistantships. Doctoral student stipends in the Department of Psychology are \$17,100 for nine months (premasters) and \$18,100 for nine months (post-masters).

Fordham University (New York, NY): Over the past several years, incoming students have been offered 100% financial aid, including 4 years of tuition remission and a stipend for each academic year.

Louisiana State University (Baton Rouge, LA): Students receiving a graduate assistantship will receive a stipend (approximately \$15,050/year) along with a full tuition waiver.

Northwestern University, Feinberg School of Medicine (Chicago, IL): The Ph.D. Program is now a fully-funded student model. Beginning in September 2018, all students admitted to the Clinical Psychology Ph.D. Program in the Department of Psychiatry and Behavioral Sciences will receive a Research Assistant Scholarship or equivalent award that provides 100% tuition remission, health insurance, and a monthly stipend.

Rutgers University (New Brunswick, NJ): All students admitted to the Ph.D. program in psychology are guaranteed 5 years of funding, provided that they maintain good status in the program. Students who enter the program with a Master's degree are guaranteed 3 years of funding. This financial aid covers tuition and includes a 10-month stipend or salary. Additional summer funding is available through teaching or grant funding.

University of Liverpool (Liverpool, United Kingdom): Available to EU citizens only, the Doctorate in Clinical Psychology is a 3-year full-time programme fully funded by the National Health Service (NHS). Trainees are registered postgraduate students in the Faculty of Health and Life Sciences and employed within Mersey Care NHS Trust.

University of Michigan (Ann Arbor, MI): The department offers a financial package that funds the five years that a student is in the graduate program. This support package combines Research Fellowships and Graduate Student Instructor (GSI) positions for a total of 5 years of support. Both Research Fellowships and GSI Positions include tuition coverage in the Fall and Winter terms, a stipend or salary, and health insurance.

University of Minnesota (Minneapolis, MN): The Department of Psychology guarantees five years of fully funded financial support for all students who are admitted to the Ph.D. program, contingent upon satisfactory performance and degree progress. Financial support includes full-time tuition, subsidized health insurance, and a nine-month stipend. Each academic year, financial support comprises some combination of the following options depending on your student goals and the sources of funding available.

University of Southern Mississippi (Hattiesburg, MS): Students are typically offered a competitive graduate stipend that includes a waiver of in- and out-of-state tuition. Stipends are paid as compensation for teaching or research assistantships or for paid community externship placements. Students are required to work 20 hours per week for their stipends and tuition waivers.

Vanderbilt University (Nashville, TN): All admitted Ph.D. students receive funding for up to five years of study. The financial package includes full tuition, a monthly stipend that is highly competitive with comparable programs around the country, and a health insurance package. Based upon presented qualifications, selected students are nominated for additional honor scholarships and fellowships awarded by both the college and graduate school.

Yale University (New Haven, CT): Graduate students in good standing in the Ph.D. program receive tuition and stipend (including summer funding) for up to five years. The most frequent form of aid is fellowships provided by University funds. Some students have outside awards from foundations or awards won in a national competition (e.g., from the National Science Foundation, the National Institute of Mental Health, or Jacob Javits Fellowships). Graduate students may also be paid for up to 10 hours per week from faculty research funds, but the work should contribute to the student's own development and be integrated into the student's full academic program.

Fully Funded Ph.D. Programs in Communications

Columbia University Journalism School (New York, NY): The standard financial aid package offered to full-time Ph.D. students consists of a living stipend and a tuition exemption for up to three years.

New York University Steinhardt School of Culture, Education and Human Development (New York, NY): The Department of Media, Culture, and Communication offers a complete funding and mentoring program to all admitted doctoral students.

Northwestern University School of Communication (Evanston, IL): All students who are admitted to our MA/Ph.D. or Ph.D. programs receive financial support packages including both fellowships and teaching assistantships. Regardless of whether applicants are domestic or international, all who are admitted to either our MA/Ph.D. or Ph.D. program receive funding.

Ohio State School of Communication (Columbus, OH): The School of Communication funds nearly every student we admit to our M.A. and Ph.D. programs with either a Graduate Associateship (teaching or research assistant) or some form of Graduate Fellowship (University or Enrichment Fellowship). Ph.D. students receive funding for three to five years depending on prior academic experience (\$2,193/month stipend plus tuition waiver for a nine month assistantship; \$1,980/month stipend for ABD students).

Purdue University Brian Lamb School of Communication (West Lafayette, IN): With few exceptions, graduate students accepted into the program receive funding, contingent on fulfilling degree milestones and requirements. Stipends funding is comparable to other Big Ten universities and peer institutions.

Simon Fraser University School of Communication (Burnaby, B.C., Canada): Ph.D. students are normally funded for a minimum of six of their first nine semesters.

Syracuse University Newhouse School of Public Communications (Syracuse, NY): Newhouse doctoral students are funded fully for three years and receive financial support from University Fellowships or research or teaching assistantships.

University of Kentucky College of Communication and Information (Lexington, KY): Both teaching and research assistantships are available to students. Typically, all students accepted into the program are fully funded.

University of Maryland Department of Communication (College Park, MD): All of our Ph.D. students are funded. For students entering with a bachelor's degree, assistantships are guaranteed for five consecutive years, as long as the student remains in good standing and is making satisfactory progress toward their degree.

University of Pennsylvania's Annenberg School for Communication (Philadelphia, PA): All ASC graduate students are fully funded for up to five years, including tuition and fees, health care, teaching and research fellowships, and dissertation research fellowships.

Fully Funded Ph.D. Programs in Computer Science

Brown University (Providence, RI): Provided a student is in good academic standing, Brown guarantees five years of financial support and students are typically funded through to completion.

Columbia University (New York, NY): Most admitted students receive full financial support through Graduate Research Assistantships or Teaching Assistantships, which consist of a monthly stipend plus full tuition exemption

Cornell University (Ithaca, NY): There are three types of funding available that are awarded to our best applicants. Each of them include a full tuition waiver, an academic year stipend and a Student Health Insurance package provided through the University.

Duke University (Durham, NC): Typically, Ph.D. students receive full funding for their graduate studies, including tuition, fees, insurance, and stipend. Stipend support comes in the form of a graduate fellowship, teaching assistantship, or research assistantship.

Georgetown University (Washington, DC): Doctoral students have full support during the academic year through scholarships and research assistantships.

Harvard University (Boston, MA): All students admitted to our Ph.D. program receive full financial support. This includes tuition, fees, and a cost-of-living stipend.

Stanford University (Stanford, CA): The department funds the Ph.D. candidates for the first quarter, after which he is expected to find an advisor, who usually funds them for the rest of their stay at Stanford.

University of Maryland-Max Planck (College Park, MD and Berlin, Germany): Admitted students receive full financial support throughout the program, including during summers.

University of Michigan (Ann Arbor, MI): The College of Engineering at the University of Michigan operates under a fully funded model for all Ph.D. students. Students receive a guarantee of full funding at the point of admission and throughout the duration of their five year program.

University of Toronto (Toronto, Canada): The Department of Computer Science will ensure that all full-time M.Sc. and Ph.D. degree graduate students receive financial support to at least the basic departmental level, provided that they are making satisfactory progress in their graduate program.

Washington University in St. Louis (St. Louis, MO): Our Ph.D. students are fully funded, including full tuition support and health insurance. As a doctoral candidate, you will also receive a generous stipend to cover living expenses and a new, high-end Apple laptop computer.

Fully Funded Ph.D. Programs in Criminal Justice & Criminology

American University (Washington, DC): Students selected for AU funding are granted a fellowship with full funding for four/five years of study. As a requirement for the fellowship, students work 20 hours a week with a faculty member. If at all possible, our graduate office will assign students to faculty members with expertise in their areas of research interest.

Arizona State University (Tempe, AZ): Each year we admit the number of doctoral students who can be fully-funded with graduate fellowships and teaching and research assistantships. These awards cover your tuition, health insurance, and also carry a stipend. Continuation of fellowships and assistantships are contingent upon funding, satisfactory progress toward the degree, and satisfactory performance in research and teaching assistantships.

Georgia State University (Atlanta, GA): Students admitted to the doctoral program in criminal justice and criminology are typically offered a graduate assistantship that includes a yearly stipend of \$18,000 and a full tuition waiver.

John Jay College of Criminal Justice (New York, NY): Criminal Justice core specialization students receive a Graduate Center or John Jay fellowship that includes tuition, a \$26,000 stipend, and health insurance for 5 years. Students receiving these fellowships are assigned as research assistants in the first year, and as teaching assistants or adjuncts years 2-5.

Indiana University of Pennsylvania (Indiana, PA): Graduate assistantships at IUP are selectively awarded to highly qualified master and doctoral graduate students. Twenty-hour and 10-hour assistantships are available and are paid a stipend, currently up to \$25,000 per year, including full or partial tuition waivers.

Northeastern University (Boston, MA): Students of this full-time, fully-funded Ph.D. program complete the degree in five years on average. Additionally, Ph.D. students are offered several benefits throughout their studies, including extensive summer research opportunities for students, one semester off from graduate assistantship responsibilities, and experiential and dissertation completion fellowships.

University of California Irvine (Irvine, CA): Ph.D. students in CLS are eligible for 12 quarters of support as a Teaching Assistant (TA), making this the most common means of financial support. A Teaching Assistantship is not only an important means of financial support (a monthly salary plus fees and tuition coverage), but the work also serves a vital role in training Ph.D. candidates, particularly those who intend to pursue academic careers.

University of South Florida (Tampa, FL): The department has funds to support selected graduate students. A Graduate Assistantship provides a \$15,000 annual stipend, tuition waiver and health insurance. Students receiving these assistantships work 20 hours per week. These are awarded on a competitive basis and all applicants are considered.

Fully Funded Ph.D. Programs in Economics

Brown University (Providence, RI): Students who are admitted to any of Brown's doctoral programs are guaranteed five years of support, including a stipend, tuition remission, a health-services fee, and a health-insurance subsidy. Average stipend amount of \$24,400 per academic year.

Cornell University (Ithaca, NY): Financial aid packages for incoming students are typically guaranteed, given satisfactory performance, through the Spring semester of the fifth year of study. Graduate research and teaching assistantships cover tuition as well as an academic year stipend and medical insurance.

Duke University (Durham, NC): Of the approximately 20 new Ph.D. students each year, 90 percent or more receive six years of funding so long as they remain in good academic standing. Students who are projected to be successful Ph.D. candidates are generally offered aid in the form of scholarships, teaching assistantships, or research assistantships. Average stipend amount of \$31,800 per academic year.

Emory University (Atlanta, GA): "Students in the economics Ph.D. program at Emory typically receive full funding for four years through the Laney Graduate School. Annual stipend of \$31,000 for five years.

Harvard University (Cambridge, MA): Economic students receive full tuition and stipend support while they are enrolled and making satisfactory progress toward the Ph.D. degree.

Johns Hopkins University (Baltimore, MD): The department offers a departmental fellowship to all enrolled students. This fellowship covers full tuition costs plus an annual stipend of \$29,000 and full student health insurance coverage.

Kansas State University (Manhattan, KS): All applicants are considered for funding by the department and most enrolled students are funded. Scholarships supplement the stipend by up to \$4,500 annually.

London School of Business (London, United Kingdom): All students offered a place on the Ph.D. programme receive full funding, which includes a tuition fee waiver and a stipend guaranteed for five years, subject to satisfactory academic performance. Average stipend amount of £20,280 per academic year.

New York University (New York, NY): NYU's Graduate School of Arts and Sciences provides for full financial aid for every full-time entering Ph.D. student for five years, conditional on satisfactory academic performance. It includes payment of tuition, coverage under an NYU health insurance plan, and an academic-year stipend and a one-time \$1,000 start-up stipend award. Average stipend amount \$26,855 per academic year.

Princeton University (Princeton, NJ): Princeton provides all admitted Ph.D. students with tuition and fellowship support for the academic year as well as continuing fellowship support for the summer months so students can continue to study and research when classes are not in session. Funding may come from a variety of sources.

Stanford University (Stanford, CA): Most first year students receive department fellowships unless they have their own source of funding outside of the university. Advanced year students going on the job market are encouraged to apply for SIEPR Dissertation Fellowships. Fellowship support provides a lump sum stipend payment at the start of the quarter and tuition support. Students on a university fellowship also receive a health insurance subsidy.

University of California Berkeley (Berkeley, CA): We are committed to supporting our students, both academically and financially. It is the policy of our department to ensure that all of our students are fully funded for at least five years as long as they are making satisfactory academic progress. Full funding includes student fees, nonresident tuition, and a stipend. Average stipend amount of \$24,000 per academic year (base stipend).

University of Chicago (Chicago, IL): All students receive full tuition, insurance, stipends and research funds for five years. Additional funding from department-based fellowships, awards, additional research work and teaching is common. External funding through extramural agencies is encouraged. \$25,000 per academic year.

University of Colorado Boulder (Boulder, CO): When you apply for admission, you will automatically be considered for funding in the form of a teaching assistantship. In addition, you may be offered a generous fellowship to help with the cost of relocation expenses. In recent years all incoming first-year students have been offered full funding in the form of teaching assistantships.

University of Edinburgh (Edinburgh, Scotland): All candidates successfully admitted to our Ph.D. programme will receive full funding at Research Council rates and will be offered an Economics Research and Teaching Scholarship if other funding is unavailable. Average stipend amount £17,000 per academic year.

University of Iowa (Iowa City, IA): You'll be guaranteed financial aid for at least five years, provided you're making satisfactory academic progress.

The financial aid package includes all tuition payments, a 10-month stipend for expenses (approximately \$18,800) and health and dental insurance. Ph.D.s earn the stipend by serving as research or teaching assistants.

University of Michigan (Ann Arbor, MI): Michigan Ross provides full funding to all students admitted to our doctoral program. We provide five years of funding, which includes a full tuition waiver, health insurance, and a generous stipend package that combines both fellowship funding and a graduate assistantship. Average stipend amount of \$30,000 per academic year.

University of Minnesota (Minneapolis, MN): Almost all admitted students receive financial aid from the Department of Economics, either in the form of teaching assistantships or fellowships. Most financial aid packages are for five years, contingent upon remaining in good academic standing. TA appointment in CLA provides a minimum stipend of \$18,479.

University of Pennsylvania Wharton School of Business (Philadelphia, PA): All admitted Wharton doctoral students are provided guaranteed funding for five years that covers the cost of tuition, fees, health insurance, and provides a stipend. In contrast with other top Economics Ph.D. programs, we only require one semester of teaching assistant work during the third year of the program, and one semester of research or teaching assistant work during the fourth year.

University of Toronto (Toronto, Canada): Every admitted Ph.D. student is offered funding of \$17,500 to \$28,000 CAD plus tuition and incidental fees (including UHIP expenses for international students) in each of their first four years. For a student without an external scholarship, this funding consists of Teaching Assistantships, Research Assistantships, and a University of Toronto Fellowship.

University of Virginia (Charlottesville, VA): Students admitted to the doctoral program will be offered a five-year aid package of \$24,000 per year (\$20,000 during the academic year, and \$4,000 during the summer); their tuition and enrollment fees are waived, and their University health insurance premium is paid for by the Department.

Vanderbilt University (Nashville, TN): Students are fully funded by a competitive package of fellowship support covering tuition and stipend for both degrees.

Washington University St. Louis (St. Louis, MO): Washington University is committed to funding most Ph.D. students for four to six years, depending on the time needed to complete their particular program. Funding typically consists of full tuition remission and 11 to 12 months of a stipend to defray living expenses. Monetary support may come from the university or from outside sources, and it may be administered by an individual faculty member or by the staff of the program or the school. Average stipend amount \$22,500 per academic year.

Yale University (New Haven, CT): The Graduate School provides full tuition, health insurance and stipend fellowship for the first six years of study. Normally the Department of Economics provides additional stipend support. There is a combined award policy that applies to students who obtain outside fellowships. This policy gives students a financial incentive to obtain outside awards.

Fully Funded Ph.D. Programs in Education

Arizona State University (Tempe, AZ): The Mary Lou Fulton Teachers College (MLFTC) offers competitive funding packages to graduate students. Most students are supported through Graduate Assistantships (GA) or Teaching Assistantships (TA).

Boston College (Boston, MA): The Lynch School has a deep commitment to assisting academically qualified students to afford an excellent graduate education. The Office of Graduate Admission & Financial Aid provides resources to support students through merit-based financial aid. As a Lynch School student, you can apply for financial assistance through a variety of scholarships, loans, stipends, and work-study opportunities.

Brigham Young University (Provo, UT): Students admitted to this program are required to be enrolled as full-time, resident students. Financial assistance is offered in the form of tuition stipends and research assistantships (20 hours per week).

City University of New York (New York, NY): All entering doctoral students in the humanities, social sciences, and the sciences will receive a five-year fellowship package. These packages include tuition remission and many also include a generous stipend and health insurance. \$23,000 per academic year (\$2,000 in summer funding is also available).

Drexel University, School of Education (Philadelphia, PA): Drexel University provides tuition remission, a living stipend and health insurance subsidies through research and teaching assistantships.

Harvard University, Graduate School of Education (Cambridge, MA): Harvard provides full financial support for Ph.D. students for all five years of the program.

Johns Hopkins University (Baltimore, MD): Each year between four and eight Ph.D. candidates will be admitted and receive full tuition assistance and a \$25,000 annual stipend to support full-time study.

New York University, Steinhardt School of Culture, Education and Human Development (New York, NY): NYU Steinhardt awards all students (including international students) who are offered full-time admission to our Ph.D. programs a full funding and mentoring package.

Northwestern University (Evanston, IL): Full tuition and academic year stipend for five years, contingent on satisfactory progress towards the degree. Stipend levels may vary year-to-year but will never fall below The Graduate School's (TGS) base stipend level (currently \$1,916/month).

Queen's University, School of Graduate Studies (Ontario, Canada): The minimum guaranteed funding package for eligible full-time Ph.D. students is \$18,000 per year, with most students receiving additional funded opportunities. Teaching and/or Research Assistantship the average funding for eligible Ph.D. students is approximately \$25,000 per year.

Stanford University (Stanford, CA): Students entering the doctoral programs at Stanford GSE receive a five-year funding guarantee which provides tuition aid, fellowship stipend and assistantship salary. Depending on your role, pay ranges from \$4,644 per quarter (25%, 10 hours per week) to \$9,726 per quarter (50%, 20 hours per week).

University of California Irvine (Irvine, CA): Effective 2015, all incoming UC Irvine Ph.D. in Education students, including California residents, non-residents, and international students, are offered five years of financial support. Funding includes an academic year stipend or salary, tuition and Student Services Fee waiver, and student health insurance.

University of Colorado (Boulder, CO): Admitted doctoral students received four-year funding packages including a stipend and a tuition grant equal to the cost of tuition (in-state and out-of-state).

University of Delaware (Newark, DE): Typically, all students in the Ph.D. program receive financial support through assistantships and tuition scholarships. All students also receive a 100% tuition scholarship for classes taken during the fall, winter, and spring semesters and receive a nine-month stipend in exchange for 20 hours of work per week.

University of Kansas (Lawrence, KS): Nearly all doctoral students receive funding. Doctoral student funding relies on a variety of funding sources.

University of Michigan (Ann Arbor, MI): The majority of students in our doctoral programs receive a minimum of four years of financial support to cover tuition, along with a stipend for living expenses during the fall and winter semesters and health insurance for the entire year. Keep in mind that the School of Education provides health and dental benefits for you and your family members.

University of Oregon (Eugene, OR): The Education Studies department is committed to providing four years of Graduate Employee (GE) support for each CSSE student. GEs are appointed to work .20 to .49 FTE or, approximately 8-20 hours/week over the course of an 11-week term. \$ 631.58 per month (.20 FTE Level 1) to \$1,845.56 per month (.49 FTE Level III).

University of Pennsylvania (Philadelphia, PA): All incoming Ph.D. students receive a fellowship package, which includes tuition and fee support, health insurance, a living stipend, and a research and teaching apprenticeship. The fellowship covers four years of study and requires that students maintain full-time enrollment. Additional funding is available.

University of Pittsburgh (Pittsburgh, PA): The federal government and private financial institutions offer loans to cover much, if not all, of the cost of your education, allowing you to gradually pay back the loan amount after you graduate. Students wishing to apply for financial aid should complete the Free Application for Federal Student Aid (FAFSA) each year. Some graduate students also receive scholarships for their studies or may be chosen to work for the school in a teaching or research position, known as an assistantship.

University of Southern California (Los Angeles, CA): "All students admitted into the Ph.D. program, who remain in good academic standing according to the terms of their annual contract, will work as research and/or teaching assistants for approximately 20 hours a week throughout the four years of the program. Annual stipend \$32,000.

University of Toronto (Toronto, Canada): Students in the funded cohort who maintain satisfactory progress in their graduate program as a full-time student will receive a funding package. \$25,490 CAD per academic year for domestic students \$39,600 CAD per academic year for international students.

University of Virginia (Charlottesville, VA): Students will receive coverage for four full years of tuition and fees, health insurance, and \$32,000 for each year of study. Additional funding may be available for students who travel to national conferences to present their research.

Vanderbilt University (Nashville, TN): "Doctoral students in the Learning, Teaching, and Diversity program typically receive full tuition support, health insurance, and graduate assistantships that cover living expenses. A significant proportion of students also receive scholarships that increase their level of financial support. Minimum of \$16,500 per academic year.

Fully Funded Ph.D. Programs in Electrical Engineering

American University of Beirut (Beirut, Lebanon): The selected Ph.D. student will join the relevant research area group led by MSFEA professors and will be identified as the Maroun Semaan Fellow after graduation. The appointment includes a monthly stipend, full tuition, and other benefits.

Lahore University of Management Sciences (Lahore, Pakistan): LUMS provides funding to Ph.D. students in terms of scholarship and research assistantship. The University's policy is to admit students purely on merit, regardless of their financial status or background. The Ph.D. Programmes at LUMS offer a full tuition fee waiver to all students on merit for four(4) years. Other types of financial assistance will include a monthly assistance package so that the students devote themselves to full time studies without fiscal restraints.

North Carolina State University (Raleigh, NC): Ph.D. students in their first four years of enrollment are guaranteed a funded appointment for fall and spring that includes a full tuition waiver and a stipend. Students are also eligible for summer support. Students must remain in good academic standing, be making good progress to your degree and successfully performing the duties of their assistantships.

Northwestern University (Evanston, IL): Students are fully funded by a combination of research assistantships, teaching assistantships, and fellowships. Students work with faculty members in state-of-the-art labs and can pursue interdisciplinary collaborations.

Princeton University (Princeton, NJ): Students maintaining good progress receive full financial support throughout the duration of the program, including a generous stipend for living expenses. No fees, no tuition.

Stanford University (Stanford, CA): All Ph.D. students who maintain satisfactory academic progress receive full financial support for the duration of the doctoral program. Interested students may apply for course assistantships and advanced teaching assistantships in the department to supplement their graduate training.

University of British Columbia (Vancouver, Canada): All full-time students who begin a UBC-Vancouver Ph.D. program in September 2018 or later will be provided with a funding package of at least \$18,000 for each of the first four years of their Ph.D.. The funding package may consist of any combination of internal or external awards, teaching-related work, research assistantships, and graduate academic assistantships.

University of Michigan (Ann Arbor, MI): Students admitted to the doctoral program in Electrical and Computer Engineering receive financial aid for the anticipated duration of studies assuming satisfactory progress is made. Financial aid consists of a fellowship, a research assistantship, a teaching assistantship, or a combination thereof. This aid normally includes a tuition waiver, stipend (approximately \$32,500 for 12 months) and health care.

University of Pennsylvania (Philadelphia, PA): Ph.D. students are typically awarded funding upon admission to cover tuition and fees, a stipend for living expenses and payment of University of Pennsylvania student health insurance.

University of Toronto (Toronto, ON): Ph.D. students who are in good academic standing and making satisfactory progress toward the completion of their degree receive a financial support package for a specified duration of their course of studies. The Department will provide all eligible graduate students with an annual base financial support package consisting of \$17,500 CAD plus the cost of applicable tuition and fees as set by the University of Toronto.

University of Washington (Seattle, Wash., U.S.A.): All admitted Ph.D. students will receive funding for four years of academic study through research and teaching assistantships, fellowships and departmental support provided they are making satisfactory progress toward their degree.

Washington University in St. Louis (St. Louis, MO USA): Our Ph.D. students are fully funded, including full tuition support and health insurance. As a doctoral candidate, you will also receive a generous stipend to cover living expenses. This support is guaranteed as you continue to make satisfactory progress towards your degree.

Fully Funded Ph.D. Programs in English

Boston College (Newton, MA): Offers a tuition remission fellowship plus a stipend for all students for five years as well as university-funded dissertation fellowships to support their research.

Columbia University (New York, NY): All admitted students are fully funded for 6 years with tuition, fees, and a living stipend, \$30,770 in total (including a grant to support research over the summer break).

Syracuse University (Syracuse, NY): All students are fully funded. Each student admitted receives a full tuition scholarship in addition to an annual stipend of \$14,535 – \$19,196. Some of these scholarships are configured to include teaching duties.

University of Chicago (Chicago, IL): Doctoral students are awarded a five-year fellowship that includes a stipend, full tuition, and health insurance coverage. Students may also apply for research and travel funds.

University of Michigan (Ann Arbor, MI): Offers a guaranteed six-year funding package to all students admitted to the program. Funding covers complete in-state and out-of-state tuition costs, health care benefits, and living expenses in the form of direct stipend and teaching. Summer funding is available in years one through five.

University of Notre Dame (Notre Dame, IN): All students admitted to the Ph.D. program can expect full funding for five years which includes tuition and stipends, plus opportunities for the sixth year.

University of Virginia (Charlottesville, VA): Financial support, including health insurance and tuition remission, is awarded to all Ph.D. students from the first through the fifth year of study, with a significant number of students receiving support in the sixth year of study.

Fully Funded Ph.D. Programs in Environmental Conservation

Boston University, Graduate School of Arts and Science (Boston, MA): The Graduate School of Arts & Science guarantees five years of full funding for Ph.D. students. Funding is met through a combination of research assistantships, teaching fellowships, and other internal and external graduate scholarships. Funding consists of full coverage of tuition, a living stipend, and basic health insurance.

Columbia University, School of International and Public Affairs (New York, NY): Full-tuition fellowships with stipends are available for all admitted students who are not already sponsored by their governments, employers, or a foundation.

University of California Irvine (Irvine, CA): All admitted students (including international students) are fully-funded. This includes a moving allowance, an annual stipend of \$32,865, tuition and fees, and UCI health insurance.

University of California Los Angeles, Institute of the Environment and Sustainability (Los Angeles, CA): It is our expectation that all students making satisfactory progress in the program will be fully funded for the duration of their studies. We will help you secure this funding through a variety of sources including faculty research grants, fellowships, teaching assistantships or other sources.

University of California San Diego, Scripps Institute of Oceanography (San Diego, CA): Scripps typically offers a five year guaranteed financial package that includes stipend/salary, tuition, and nonresident supplemental tuition. US citizens and permanent residents who are not California residents are typically awarded one year of nonresident supplemental tuition, after which they are then expected to become a California resident.

University of Pennsylvania (Philadelphia, PA): All students admitted to the program receive financial support for a minimum of five years. New students receive a non-service Educational Fellowship which allows them to focus entirely on lab selections and coursework during their first year. In subsequent years, students are supported through various means, such as teaching assistantships, research fellowships, training grants, and other means, both University fellowships and outside funding.

Yale University, School of Forestry and Environmental Studies (New Haven, CT): Doctoral students receive a School Fellowship which provides a stipend and a tuition waiver for the first five years of their studies. For the 2019-2020 academic year, the stipend is \$31,800. Teaching experiences are regarded as integral parts of the graduate training program at F&ES. All students are required to serve as teaching fellows (minimum of 10 hours per week) for four semesters prior to the end of their fifth year of study.

Fully Funded Ph.D. Programs in French

Brown University (Providence, RI): Students in our program are guaranteed a competitive package of six years of academic year funding and four summers of financial support with full tuition remission and health and dental insurance coverage. Students are eligible for a dissertation fellowship during the fifth or sixth year. Additional summer funding is provided while they prepare for their preliminary exam, and a stipend for research travel is available during their dissertation fellowship year. Students are also guaranteed funding each year for conference travel or other research needs.

Columbia University (New York, NY): Doctoral students normally receive the annual prevailing stipend and appropriate tuition and health fees for five years, provided that they remain in good academic standing and, in the case of student officers, have discharged responsibly their pedagogical or research duties. For doctoral candidates in Humanities and Social Science departments, this includes five summers of support.

Tulane University (New Orleans, LA): The Ph.D. program is fully funded for 5 years for students entering with a BA degree (4 years for students entering with an MA). Students admitted to the program receive full tuition remission and a stipend of \$26,000. They also have the opportunity to apply for competitive summer research funding through the Beth Poe Travel Grant (currently worth \$5000) and the Summer Merit Fellowship Award (up to \$5000), and for conference travel grants during the school year of up to \$2250 annually (through the GSSA Fund, the Land Fund and the Alfred Mercier and Lafcadio Hearn Travel Grants).

University of Chicago (Chicago, IL): All Romance Languages and Literatures Ph.D. students are awarded 6-year fellowships that include a stipend and teaching remuneration, full tuition, and health insurance coverage.

University of Colorado at Boulder (Boulder, CO): Financial aid for qualified Ph.D. students is available in the form of Teaching Assistantships, Graduate Part-Time Instructorships, and Graduate School Fellowships. Teaching Assistantships and Graduate Part-Time Instructorships normally include responsibility for lower-level language classes. The average stipend for this is approximately \$26,000, and it carries with it a waiver of tuition costs. The

University of Maryland (College Park, MD): A number of Graduate Teaching Assistantships are awarded each year. These carry 9.5-month stipends, remission of all tuition (10 credits per semester), and eligibility for employee health benefits. (UMD mandatory fees are not covered.) For more information, click here.

University of Pennsylvania (Philadelphia, PA): All students admitted to the Graduate Program in French & Francophone Studies receive a Benjamin Franklin Fellowship, which guarantees five years of financial support (tuition remission, Penn's health insurance, and a stipend–\$29,678 in 2019-20) to students who continue in good academic standing. Students will also receive summer stipends (July and August) in their first three years on the Benjamin Franklin Fellowship. The fellowship requires a two-year teaching assistantship as service to the department.

University of Texas at Austin (Austin, TX): The University of Texas at Austin is pleased to offer 6-year scholarship packages of up to \$30,000 annually for graduate study in French Studies and French Linguistics.

University of Wisconsin-Madison (Madison, WI): The Department of French & Italian is committed to providing full funding to all graduate students. Students who accept our offer of admission therefore receive fellowships or assistantships that cover tuition and provide eligibility to enroll in excellent comprehensive health insurance and other benefits. Funding for Fall 2020 and beyond is projected to be guaranteed for a minimum of 5 years of study for students entering with a B.A., and a minimum of 4 years for those entering with an M.A.

Yale University (New Haven, CT): All Yale students receive full financial support (tuition plus full stipend, including health insurance coverage) for five years of graduate study. This includes two years of coursework without teaching, two years of teaching, and a dissertation fellowship year. Students in the French Department who choose to pursue dissertation research in France or a francophone country receive an additional year of support without having to teach.

Fully Funded Ph.D. Programs in Geography

Clark University (Worcester, MA): All incoming graduate students are guaranteed the same tuition remission and a minimum of three years of initial assistantship funding, as long as progress towards a degree is satisfactory.

Florida State University (Tallahassee, FL): Current funding for qualified students is \$18,014 per year (fall and spring) plus all tuition credit hours (with a possibility of summer teaching for an additional \$2,500). Students are liable for FSU fees. Funding for students with a master's degree is for 4 years, and 5 years for students without a master's degree. In both cases, funding is conditional on good scholastic standing and available Departmental resources.

Indiana University Bloomington (Bloomington, IN): We offer competitive opportunities for graduate funding, including research assistantships, associate instructorships, and fellowships. Our Ph.D. students are normally funded for 5 years, given adequate progress. IU Geography does not fund terminal Master's degrees.

Louisiana State University (Baton Rouge, LA): The Geography and Anthropology department currently funds approximately 20 students through departmental teaching assistantships. All applicants who submit complete applications by the deadline will be considered for funding. We seek highly qualified students who will contribute to expanding the diversity of the disciplines of Geography and Anthropology.

University of British Columbia (Vancouver, Canada): We work with every student to try to provide a consistent, basic level of funding of a minimum \$23,000 in income per year to all graduate students. Most of our full-time MA/MSc and Ph.D. students receive income in the form of scholarships/fellowships and/or teaching/research assistantships.

University of Minnesota (Minneapolis, MN): All students are guaranteed a funding package contingent on satisfactory progress toward a degree. The funding package provides payment of tuition up to 14 credits per semester, partial payment of the health insurance premium, and a stipend.

University of Utah (Salt Lake City, UT): Ph.D. students are eligible to receive teaching and research assistantship funding. These positions are awarded on a competitive basis and include a tuition waiver and subsidized health insurance. A Masters's degree is required to enter the Ph.D. program.

Fully Funded Ph.D. Programs in Health Informatics

Case Western Reserve University (Cleveland, OH): All first year students in the Ph.D. program are fully funded by the School of Medicine (Stipend, Tuition, and Health Insurance are included). After the conclusion of their first year, students will be supported by grants (research and training) held by their research mentor.

Columbia University (New York, NY): Ph.D. students are fully funded, either by the National Library of Medicine (NLM) training grant, a faculty grant, or other sponsorship (e.g. government or foundation scholarship or industry fellowship).

Harvard University (Boston, MA): Students receive full tuition and stipend support while they are enrolled.

Stanford University (Stanford, CA): All of our Ph.D. students are fully funded. The NLM training grant is available to Ph.D. students and post-doctoral MS students who are US citizens or permanent residents, and covers tuition, stipend, and health insurance. International students will need to find other sources of support; Ph.D. candidates may be eligible for the Stanford Graduate Fellowship.

University of California Irvine (Irvine, CA): We offer full funding for all students in our Ph.D. programs, for the full duration, as long as you continue to make satisfactory academic progress toward the degree. Students can receive funding through appointments as a Teaching Assistant (TA) or Reader.

University of Michigan (Ann Arbor, MI): Accepted doctoral students are guaranteed full funding (stipend, benefits, and tuition), contingent on academic performance and progress toward their degree.

University of Texas at San Antonio (San Antonio, TX): Full-time Ph.D.'s are generally funded with our financial package which consists of a research or teaching assistantship with paid tuition and fees for up to four (4) years.

Yale University (New Haven, CT): Financial assistance is provided to all Ph.D. students in the form of YSPH Fellowships, Teaching Fellowships, Traineeships and Research Assistantships. All admitted Ph.D. students are guaranteed five years of 12-month stipend and tuition support. In addition to grants and fellowships for tuition and living costs, students receive a Health Award, which covers the full cost of single-student Yale Health Plan Hospitalization/Specialty Coverage.

Fully Funded Ph.D. Programs in History

Boston University (Boston, MA): All applicants accepted for the Ph.D. program will receive full funding for 5 years which includes tuition and University-related fees, travel fellowships also available.

Columbia University (New York City, NY): Every student entering the Ph.D. program will receive a full fellowship (tuition, fees, and a stipend) upon admission. Students awarded such funding upon admission will receive five years of support (except for those entering with advanced standing, who will receive four years of support).

Cornell University (Ithaca, NY): Admitted Ph.D. students are guaranteed five years of full funding from Cornell, which will cover tuition, living stipend and health insurance. This includes four summer living stipends.

Georgetown University (Washington, DC): Stipend (\$29,000 in 2019-2020) and tuition support (nine credits) for five years, two additional years of tuition support, and health insurance for the duration of the fellowship.

New York University (New York City, NY): History doctoral students receive full funding support for five years (four for students entering with an M.A. who choose to count those credits) fellowships cover tuition, registration, service fees for the degree program, student health insurance, and a 9-month stipend towards expenses.

Pennsylvania State University (State College, PA): Guaranteed four to five years of funding to every student admitted and teaching lectureships offered for another two years for students in good standing to finish up their doctoral program.

University of Notre Dame (Notre Dame, IN): All graduate students admitted to the Ph.D. program are guaranteed funding for full tuition and a stipend for five years. Funding is also available to support travel to present research papers at conferences and for summer research fellowships.

University of Virginia (Charlottesville, Virginia): Students admitted to the Ph.D. program are awarded fellowship packages renewable for up to five years, financial packages include a stipend for living expenses, tuition remission, and cover the cost of University fees and single-coverage health insurance.

University of Washington (Seattle, WA): Students in their first five years of study at the University of Washington are guaranteed financial support via Academic Service Employment (TA, RA, SA) that includes a stipend, tuition, and benefits at the rates set by the Graduate School.

Fully Funded Ph.D. Programs in Information and Library Science

Indiana University (Bloomington, IN): We offer up to four years of funding to accepted students in the form of research, teaching, and service assistantships, including tuition waivers and generous stipends. We also offer travel support for our Ph.D. students.

iSchool at Illinois (Champaign, IL): The iSchool is generally able to offer full support for Ph.D. students for four years. Financial support includes a combination of the following: Research assistantships, Teaching assistantships, Fellowships (tied to the dissertation process).

Simmons University (Boston, MA): The Ph.D. program offers full tuition coverage for a limited number of students every year. In addition, scholarships, fellowships, and teaching opportunities are available to students in the SLIS Ph.D. program.

University of Arizona (Tucson, Arizona): We prioritize funding for Ph.D. students in their first three years of study. Opportunities exist within the School of Information and on campus for graduate assistantships, scholarships, and other forms of support.

University of British Columbia (Vancouver, BC, Canada): As of September 2018, all full-time students who begin the iSchool Ph.D. program will be provided with a funding package of at least \$18,000 for each of the first four years of the Ph.D. program. International students are eligible for the international tuition award of \$3,200 per year for four years.

University of Maryland College of Information Studies (College Park, MD): We guarantee funding for all admitted full-time students. We also welcome self-funded part-time students working in areas that complement their doctoral research.

University of North Carolina (Chapel Hill, NC): SILS typically provides support for full-time doctoral students during their first 4-5 years of study. There are a number of sources of support. Typical sources of support for SILS doctoral students include UNC Graduate School fellowships, research and teaching assistantships within SILS, and small fellowships that supplement the assistantship stipend.

University of Toronto (Toronto, Ontario): The Faculty of Information provides competitive funding packages for all full-time Ph.D. students. The Ph.D. funding package is intended to promote scholarly excellence, research and teaching development, and timely completion of the program.

University of Washington Information School (Seattle, WA): All applicants who are admitted to the program receive guaranteed funding for at least 4 years. Financial support includes a tuition waiver and a stipend that comes from a variety of sources including Teaching Assistantship (TA) and Research Assistantship (RA) positions, as well as student grants funded by both the UW and the Information School.

University Of Wisconsin-Madison (Madison, WI): By admitting a small cohort of doctoral students each year, we can ensure that each student develops close working relationships with faculty members, receives strong and consistent advising, and is fully funded including tuition, stipend, and health insurance.

University of Wisconsin-Milwaukee (Milwaukee, WI): Full-time doctoral students are eligible for research assistantships and teaching assistantships. Assistants receive monthly pay, tuition remission, and health insurance coverage based on the Graduate School Schedule. SOIS offers several funding opportunities for its Ph.D. students based on the availability of funding.

Fully Funded Ph.D. Programs in International Relations and International Development

American University, School of International Service (Washington, DC): All those admitted to the SIS Ph.D. program as full-time students and who maintain good progress toward completing the degree are granted a Dean's Fellowship in each of the first four years of study, unless a student opts to waive financial aid.

Columbia University, School of International and Public Affairs (New York, NY): Full-tuition fellowships with stipends are available for all admitted students who are not already sponsored by their governments, employers, or a foundation. The fellowships are open to all admitted students regardless of citizenship.

Stanford University, Department of Political Science (Stanford, CA): The department offers a standard package, consisting of a stipend and the payment of tuition and fees, to most incoming students. Both domestic and international students are eligible for this standard package. Although the Department cannot formally guarantee support beyond the first year, it expects to continue to provide an additional four years of support to students making satisfactory academic progress. This assistance normally covers the full cost of tuition and an additional amount for living expenses during the academic year. The latter amount is usually in the form of a stipend, teaching assistantship, or research assistantship.

University of California Berkeley (Berkeley, CA): The Political Science department supports its graduate students through a combination of department fellowships, university multi-year fellowships, and teaching and research assistantships. Most incoming students are awarded five years of funding support consisting of fees and non-resident tuition, and student health insurance. All funding packages are contingent on meeting minimum academic and residency requirements throughout the tenure of support. United States citizens and Permanent Residents are required to achieve California residency by the end of their first year in California to receive continued fee support.

University of Chicago (Chicago, IL): Most successful applicants receive a University fellowship. Currently, the fellowship offers are tuition plus \$31,000 annually in stipend and teaching salary. The fellowship also includes University student health insurance and four summer grants in the amount of \$4,000 each. In the third through fifth year of these fellowships, a portion of the stipend award comprises teaching service for the College.

University of Denver, Josef Korbel School of International Studies (Denver, CO): The Josef Korbel School provides a three year full tuition waiver and living stipend for most applicants accepted to the doctoral program. In addition, doctoral candidates can take advantage of opportunities to serve as research assistants at the Josef Korbel School.

University of Guelph (Guelph, Ontario, Canada): Ph.D. students who are accepted at the University of Guelph are guaranteed a minimum stipend of \$17,500 per year over three years of full-time study.

University of Ottawa (Ottawa, Canada): The Faculty of Social Sciences has a minimum funding policy that guarantees funding of at least \$19,000 for each of the four years of doctoral study to all new doctoral students meeting the requirements described below. A fifth year of funding is available under certain conditions.

Fully Funded Juris Doctorate (JD) and Ph.D. Programs in Law

Yale University, Ph.D. in Law (New Haven, CT): Law Ph.D. students will receive a full tuition fellowship, and a stipend at an amount set by the Graduate School (for the 2019-1920 academic year, this will be \$43,300), Yale Basic Health coverage, and a Health Award covering the cost of hospitalization and specialty coverage.

Vanderbilt University, Ph.D. in Law and Economics (Nashville, TN): Law and economics students are fully funded by a competitive package of fellowship support covering both tuition and stipend.

Northwestern University, Ph.D.-JD in Law (Chicago, IL): Northwestern offers the most financially generous JD-Ph.D. program in the country, typically providing full funding—including tuition and living expenses—for six academic years and three summers, for up to five students per year.

Cornell University, Dual Ph.D.-JD in Developmental Psychology and Law (Ithaca, NY): Full funding for Ph.D. graduate studies in Human Development.

Arizona State University, Ph.D. in Justice Studies (Tempe, AZ): Each year we aim to admit the number of doctoral students who can be fully funded with graduate fellowships and teaching and research assistantships. These awards cover your tuition, health insurance, and also carry a stipend.

Fully Funded Ph.D. Programs in Linguistics

Brown University (Providence, RI): The graduate school offers incoming doctoral students five years of guaranteed financial support, including a stipend, tuition remission, a health-services fee, and health- and dental-insurance subsidies.

University of California Santa Cruz (Santa Cruz, CA): An informal promise is made to each student admitted to the Ph.D. program that they will receive funding for the 5 years that it takes to complete the Ph.D.

University of Hawaii Manoa (Honolulu, HI): The Department of Linguistics provides all Ph.D. students with full support (a graduate assistantship that includes a stipend and a full tuition waiver) for eight semesters.

McGill University, Department of Linguistics (Montreal, Canada): Five years of funding for Ph.D. students (covering living expenses, tuition and fees) is provided for successful applicants.

Northwestern University (Evanston, IL): Ph.D. students receive payment of tuition, either in the form of a departmental scholarship or an external fellowship that covers some portion of the cost of education, fully subsidized health insurance, and a stipend for a minimum of five years.

University of Pittsburgh (Pittsburgh, PA): Funding can be renewed for up to a maximum total of 5 years for a Ph.D. student and includes a fellowship covering all tuition and fees, full medical coverage and a stipend earned through an assistantship.

University of Rochester (Rochester, NY): The Department of Linguistics invites applications from students interested in pursuing a fully-funded joint Ph.D. program in Linguistics focusing on cross-disciplinary training and collaboration. Students will have a primary focus in Linguistics, with a secondary focus in another department in Arts, Sciences and Engineering.

University of South Carolina (Columbia, SC): The Linguistics Program at the University of South Carolina makes the financial support for its graduate students a priority. All Ph.D. students in the program are fully supported for 4 years.

Fully Funded Ph.D. Programs in Mathematics

Baylor University (Waco, TX): Funding for the first four years of the Ph.D. is automatic and includes a \$22,500 per year stipend and full tuition remission plus health benefits.

Cornell University (Ithaca, NY): All full-time students in Applied Mathematics receive a full support package and are guaranteed five years of funding, subject to satisfactory academic progress.

University of Pennsylvania (Philadelphia, PA): Full-time students admitted to our Ph.D. program are offered a financial support package combining fellowships and teaching assistantships. The package covers tuition and fees, health insurance and also provides a stipend for five years.

Princeton University (Princeton, NJ): Princeton guarantees funding for its regularly enrolled, degree-seeking Ph.D. candidates for all years of regular program enrollment. Over a Ph.D. student's years of regular enrollment, this funding may come from a variety of sources, which in combination provide a minimum level of annual support that includes full tuition and fees support and a base stipend amount.

Rice University (Houston, TX): The fellowship for Ph.D. students includes a stipend for living expenses from the department and a tuition waiver from the Office of Graduate and Postdoctoral Studies. Historically, doctoral students who have performed well continue to receive financial support in the form of research assistantships during their entire doctoral studies.

Stanford University (Stanford, CA): All admitted Ph.D. students who make satisfactory progress are fully funded for five years. Funding sources include department fellowships, teaching assistantships and research assistantships.

Syracuse University, Department of Mathematics (Syracuse, NY): There will be an estimated 10-12 teaching assistantships for 2020-2021. In AY 2019-2020, the stipends were between \$19,000 and \$22,500 and each teaching assistantship includes a tuition scholarship for 24 credit hours per academic year.

Fully Funded Ph.D. Programs in Machine Learning

Carnegie Mellon University, School of Computer Science (Pittsburgh, PA): Admitted Ph.D. students receive full tuition and stipend support for the academic year for a period of 5 years.

Machine Learning at John Hopkins University (cross-departmental studies) (Baltimore, MD): Most Ph.D. students at JHU are fully funded for tuition, stipend, and health insurance, through a mix of research assistantships, teaching assistantships, training grants, and fellowships.

Cornell University, Department of Computer Science (Ithaca, NY): All students who are accepted will obtain a fully funded fellowship that covers tuition, 12 months salary and health insurance.

University of Cambridge – Tübingen Ph.D. Fellowships in Machine Learning (Cambridge, United Kingdom & Tübingen, Germany): Available funding for up to four Ph.D. Fellowships covering university tuition fees (at Cambridge EU rates) and a stipend of approximately 17,000 Euros.

University College London, Gatsby Computational Neuroscience Unit (London, United Kingdom): Students at the Gatsby Unit study toward a Ph.D. in either machine learning or theoretical neuroscience. The Gatsby Ph.D. studentships cover the cost of tuition at the appropriate rate, and include a tax-free stipend of £23,500 per annum. Full funding is available to all students, regardless of nationality.

Stanford University (Stanford, CA): Most Computer Science Ph.D. students are supported by a research or teaching assistantship in Computer Science or the School of Engineering (SOE), or by a fellowship, or by an approved assistantship through a collaborating research organization. The SOE's Ph.D. program is full-time and requires full tuition, most or all of which is normally covered by such support.

Fully Funded Ph.D. Programs in Mechanical Engineering

Boston University (Boston, MA): The College of Engineering is committed to five full years of financial support for graduate students in the CoE Ph.D. program who maintain Satisfactory Academic Progress. Entering Ph.D. students are fully funded in their first year. During the first year, incoming Ph.D. students have to pursue research and funding discussions with the research faculty. At the end of the first academic year, Ph.D. students must move to RA funding, while others continue on their external fellowship if applicable.

Carnegie Mellon University (Pittsburgh, PA): The majority of full-time Ph.D. students accepted through the standard application process receive fellowships that cover full tuition, the technology fee, and a stipend for living expenses for up to five years, as long as sufficient progress is made toward degree completion. These awards are sufficient to cover all expenses for the year (including summers).

Columbia University (New York, NY): At the time of admission to a terminal doctoral program, the Department of Mechanical Engineering guarantees a minimum of five years of financial support, contingent on maintaining Good Academic Standing within both the Department of Mechanical Engineering and the Graduate School of Arts and Sciences. Financial support comes in the form of teaching assistantship, graduate research assistantship, or fellowship, and may change from year to year or semester to semester.

Duke University (Durham, NC): The Graduate School at Duke provides a competitive package that should provide Ph.D. students with financial support for the majority of the time they are registered and working toward their degree. Ph.D. students are supported in a variety of ways, including funding from their departments, The Graduate School, or other governmental and private sources.

Florida A&M University-Florida State University College of Engineering (Tallahassee, FL): The FAMU-FSU College of Engineering Ph.D. programs offer competitive funding packages for newly admitted students. These may include research assistantships and/or teaching assistantships, tuition waivers, student health care coverage and/or monthly living stipends.

Johns Hopkins University (Baltimore, MD): All Ph.D. students are fully funded with tuition, stipend, and benefits (including healthcare) for the entire duration of the program.

University of Michigan (Ann Arbor, MI): Students admitted to the Ph.D. program will be offered a full funding package for their studies. The offer entails 4 years of funding for students that come into the program with a master's degree in a relevant area of study; or 5 years of funding for students that enter the program after receiving a bachelor's degree. Financial support includes a stipend, tuition and registration fees, as well as health and dental benefits.

University of Michigan-Dearborn (Dearborn, MI): Our Ph.D. program adheres to the CECS full-funding model for Ph.D. students. All Ph.D. students receive full-funding in the form of an appointment as a Graduate Student Instructor (GSI), Research Assistant (GSRA), or a combination of both which covers: a monthly stipend, health insurance, and tuition waiver.

University of Pennsylvania (Philadelphia, PA): All Ph.D. students who are in good academic standing are provided with financial aid that covers full tuition, a stipend, and health insurance throughout their program of study in the department. The financial aid is funded by research grants of faculty members, endowments, and other fellowships. The selection process is competitive and is based on merit.

Washington University in St. Louis (St. Louis, MO): Our Ph.D. students are fully funded, including full tuition support and health insurance. As a doctoral candidate, you will also receive a generous stipend to cover living expenses. This support is guaranteed as you continue to make satisfactory progress towards your degree.

Fully Funded Doctor of Medicine (MD) - Ph.D. Programs

Dartmouth University Geisel School of Medicine (Lebanon, NH): The MD-Ph.D. program provides medical school tuition deferment (which becomes a full waiver upon completion of the Ph.D.), health insurance and a competitive stipend for its trainees. For the 2014/15 academic year, the stipend is \$27,720.

Duke University School of Medicine (Durham, NC): All students admitted to the MST (Medical Scientist Training) Program receive a full fellowship award: tuition; fees; health insurance; and a stipend to cover living expenses. The annual award for first-year MD students for 2019-2020 totals \$95,839. The stipend is \$31,747 for twelve months, and the fees/tuition/health insurance award is \$64,092.

Harvard/M.I.T MD-Ph.D. Program, Harvard Medical School (Boston, MA): Applicants accepted through the MSTP receive full tuition, medical insurance, and stipend support throughout their training, contingent on continued academic progress.

John Hopkins University School of Medicine (Baltimore, MD): All eligible applicants who are admitted to the MD-Ph.D. Program are considered for funding under the Medical Scientist Training Program. This program, supported by the National Institutes of Health, provides full tuition, stipend, and insurance for students. Due to federal restrictions, only U.S. citizens and permanent residents are eligible for MSTP funding.

Mayo Clinic Graduate School of Biomedical Sciences, Medical Scientist Training Program: MD-Ph.D. (Rochester, MN; Phoenix, AZ; Jacksonville, FL): Matriculating students receive a stipend (currently \$32,569/year) as well as tuition waivers for up to 8 years (4 years of medical school and 4 years of Ph.D.).

University of Florida College of Medicine (Gainesville, FL): The MD-Ph.D. Training Program offers a full stipend scholarship and tuition waiver for up to 4-8 new students each year for the entire period of their training.

University of Southern California Keck School of Medicine (Los Angeles, CA): All MD/Ph.D. students receive fully funded scholarships that include an annual stipend and full tuition and fee waivers for the MD years from the MD/Ph.D. program. Complete support during the Ph.D. training will be provided for each student by the specific graduate department, program and/or research preceptor.

Yale University School of Medicine (New Haven, CT): All students in Yale's MD-Ph.D. Program are supported fully with stipend, tuition and basic health coverage for the duration of training.

Fully Funded Ph.D. Programs in Music

Brandeis University (Waltham, MA): Funding includes a competitive fellowship, a full-tuition scholarship, and health insurance benefits. All doctoral candidates teach some semesters as part of their academic program.

Brown University (Providence, RI): All Ph.D. students receive full funding for 5 years, including costs for tuition and health insurance, plus stipends for fellowships and teaching assistantships.

City University of New York (New York, NY): All students admitted into the Graduate Center music programs will receive tuition remission. Most Ph.D. and several D.M.A. students will receive a 5-year Graduate Center Fellowship.

Cornell University (Ithaca, NY): Every student accepted into the Ph.D. program at Cornell receives five years of guaranteed funding, including financial support for four summers. Every student is given a fellowship for the first year; a second year of fellowship year may be taken in the fourth or fifth year, or may be deferred if outside funding is procured by the student. The remaining three years of funding are in the form of teaching assistantships. Student Health Insurance is provided under fellowship and teaching assistantships.

Duke University (Durham, NC): All admitted students to the graduate program in the Duke Department of Music received a Fellowship, which includes full tuition and an income stipend for the five years of the program.

Georgia Institute of Technology (Atlanta, GA): Our Ph.D. in Music Technology is a fully funded program, including a monthly stipend and tuition waiver. In this program, our students focus on novel research with a broad impact on music, collaborating with faculty on a variety of topics.

Harvard University (Boston, MA): Graduate students are awarded six years guaranteed funding (including living expenses) when accepted to a Ph.D. program.

Princeton University (Princeton, NJ): All Music Department graduate students receive a tuition scholarship and a 12-month stipend for the full five years of the program. Additional resources include a research budget (Bryan Fund), funding for summer language study, and subsidized private voice or instrumental studio instruction. After the five-year program, students are eligible to be nominated by the graduate school for sixth-year funding and may supplement their income with teaching as available.

Stanford University (Stanford, CA): In the first year, all students receive full tuition and a fellowship stipend. During years 2-5, students receive tuition and a salaried assistantship. Two summers are also provided for and include tuition and a salary as a research assistant.

Fully Funded Ph.D. Programs in Neuroscience

Brown University, Department of Biology and Medicine (Providence, RI): Full funding via fellowship, teaching assistantship and research assistantship is available for those admitted to the Ph.D. program.

Harvard University, Department of Medicine (Cambridge, MA): All Program in Neuroscience students (both domestic and international) receive full funding for the duration of their enrollment. Funding includes full tuition and fees, health insurance, and a stipend for living expenses. (For the fiscal year starting July 1, 2018, the stipend is \$38,376/year.)

Georgetown University, Department of Neuroscience (Washington, DC): The Interdisciplinary Program in Neuroscience provides competitive stipend support and health insurance benefits for all qualified students. Full tuition is also paid by the program.

UC San Diego, Department of Neuroscience (San Diego, CA): The first year of student funding is provided by the Neurosciences Graduate Program. This includes full payment of tuition and fees and a stipend of \$34,000/year for 2018-19. Beginning Fall Quarter of the second year, your thesis advisor assumes responsibility for providing full financial support.

Stanford University, School of Medicine (Stanford, CA): Students are fully funded for their entire course of study and receive a stipend of \$33,172 per year.

Boston University, School of Medicine (Boston, MA): For the first year, most Ph.D. students will either be funded by an early stage T32 neuroscience training grant or by the University. After the first year of coursework and laboratory rotations, students join a lab and are typically funded by that lab, or by an individual training grant, until completion of their degree.

Ohio State University, College of Arts and Sciences (Columbus, OH): As a student in the Neuroscience Graduate Program you will receive funding as a Graduate Research Associate or a Graduate Fellow and receive full payment of tuition, health insurance and an annual stipend of \$27,576.

Fully Funded Ph.D. programs in Nursing

Betty Irene Moore School of Nursing at UC Davis (Sacramento, CA): Each student admitted to the doctoral degree program at the Betty Irene Moore School of Nursing receives generous financial support to cover in-state tuition, fees and additional expenses. Students are also eligible to apply for additional funding through various external sources.

Boston College Connell School of Nursing (Chestnut Hill, MA): We fully fund every full-time student's tuition, fees, & insurance for three years. The Connell School and Boston College offer multiple opportunities to fund a graduate education. CSON graduate students receive financial assistance through internal and external sources—including scholarships, fellowships, grants, teaching and research assistantships, and tuition remission.

Cizik School of Nursing at UTHealth (Houston, TX): Doctoral Fellows will receive funding for full tuition and fees on a semester basis. As long as the Fellow is in good academic standing and meets the established objectives and benchmarks, she or he will continue to receive financial support for their education. Funding amounts are adjusted per the student's approved part-time or full-time degree plan.

Columbia University School of Nursing (New York, NY): Columbia Nursing provides three years (eight semesters) of funding for tuition, related fees, health insurance, and stipend (based on current NIH rates) to students who are U.S. citizens or permanent residents. Tuition and Fees, Health Insurance are covered and an annual Stipend of \$25,320 is provided.

Duke University School of Nursing (Durham, NC): Ph.D. student tuition and 12-month stipends are fully funded for the first two years of the program. Tuition and 9-month stipends are fully funded in years 3-5 and students have the option to apply for competitive summer stipends in years 3-5. Additional financial support for health insurance and fees is available.

Nell Hodgson Woodruff School of Nursing (Atlanta, GA): All full-time admitted students are granted full tuition waiver and receive an annual stipend of \$31,000 over 12 months in exchange for teaching and research services. These awards are renewed each year, contingent upon satisfactory academic performance, for a total of four years.

NYU Rory Meyers College of Nursing (New York, NY): Our full-time Ph.D. students are guaranteed three years of funding, consistent with our peer institutions. Students receive tuition and stipend support for a three-year period; however, the College encourages and offers resources for students to prepare proposals for predoctoral funding either through the National Institutes of Health or other organizations.

The Johns Hopkins University School Of Nursing (Baltimore, Maryland): Most full-time Johns Hopkins Nursing Ph.D. students are 100% funded with a stipend for the first three years of study. Additional financial support is made available in following years.

The University of British Columbia (Vancouver, BC, Canada): Applicants to UBC have access to a variety of funding options, including merit-based and need-based. All full-time students who begin a UBC-Vancouver Ph.D. program will be provided with a funding package of at least \$18,000 for each of the first four years of their Ph.D..

University of California Irvine Sue & Bill Gross School of Nursing (Irvine, CA): Financial support is guaranteed for the first four years of the Ph.D. program. Funding sources are available in the form of fellowships, teaching assistantships, research assistantships, campus scholarships, and grant awards. Students are especially encouraged to apply for grant funding in year four and five.

University of California San Francisco (San Francisco, CA): In-state tuition/fees and a stipend are covered for our Ph.D. students for the first three years. For the fourth and fifth years, funding support is contingent on the availability of scholarship and grant funding.

University of Michigan School of Nursing (Ann Arbor, MI): The UMSN is committed to assisting students with the financing of their nursing education and as such offers an attractive funding package (e.g., full tuition support, monthly stipend, and health insurance) that enables students to study full-time (available to students in the 3-year Accelerated or 4-year Traditional Programs) while providing the opportunity to gain valuable research experience learning from their faculty research mentor.

University of Pennsylvania School of Nursing (Philadelphia, PA): Full-time doctoral students are funded for the first four years, which includes a living stipend and covers tuition, fees, and health insurance. Students may be funded internally or externally, depending on funding options available.

University of Rochester School of Nursing (Rochester, NY): All full-time UR School of Nursing students are 100 percent funded with full tuition waivers and an additional cost-of-living stipend of \$25,000 for the first four years of study. Additional financial support is facilitated in following years through assistance with student applications for a wide range of funding for continued Ph.D. study and research.

University of Toronto, Lawrence S. Bloomberg Faculty of Nursing (Toronto, Ontario): The base funding package normally consists of 3 elements: Tuition fee, Award and Teaching Assistantship. Overall, the minimum value of the base funding package is \$17,250 plus the tuition fee, or approximately \$25,050.

University of Virginia School of Nursing (Charlottesville, VA): We provide 4 years' free tuition and generous annual stipends for ALL admitted students. All US citizens and permanent residents admitted to the Ph.D. program are eligible to be awarded two to three years of scholarship to cover in-state tuition, including summers during that time period. In exchange, all Ph.D. students serve as a GTA. Full-year GTAs earn a modest stipend and receive health insurance.

Western University School of Graduate and Postdoctoral Studies (Ontario, Canada): Western guarantees minimum annual funding for doctoral students, from all sources, of \$13,000 plus tuition. In addition to the financial support available from federal and provincial sources and research grant support, Western offers a variety of internal awards.

Yale University School of Nursing (New Haven, CT): All students are fully funded, including tuition, healthcare, and a monthly stipend for 4 years. Students are mentored to seek additional funding for their dissertation, including NIH (F31), Sigma Theta Tau, American Nurses Foundation, among others.

Fully Funded Ph.D. Programs in Nutrition and Food Science

Baylor University, Ph.D. in Exercise and Nutrition Sciences (Waco, Texas): Depending on funding availability, we typically accept 2-3 new students per year into this program. Doctoral students are usually funded to work on Baylor Laboratories for Exercise Science and Technology grants, research, or assigned as TA's. The stipend for this assistantship is currently set at \$24,000 paid out across all academic terms (fall, spring, summer) beginning in fall 2019. In summer, you will be working primarily as a research assistant.

Columbia University, Ph.D. in Nutrition and Metabolic Biology (New York, NY): Doctoral students normally receive the annual prevailing stipend and appropriate tuition and health fees for five years, provided that they remain in good academic standing and, in the case of student officers, have discharged responsibly their pedagogical or research duties. For doctoral candidates in Humanities and Social Science departments, as well as Mathematics and Statistics, this includes five summers of support.

Cornell University, Ph.D. in Food Science (Ithaca, NY): Only applicants for whom we can identify funding for will be admitted to our program. Graduate assistantships include: full tuition, health insurance and an annual stipend of approximately \$36,000. Renewal of financial support each semester is contingent upon academic performance constituting good standing in the graduate field and satisfactory performance in any teaching or research responsibilities.

New York University Steinhardt, Ph.D. in Nutrition and Dietetics (New York, NY): The department offers our full-time doctoral students a competitive funding program that includes tuition and living expenses and includes teaching opportunities, and faculty mentoring. All doctoral applicants regardless of citizenship will be considered for scholarships, assistantships, and fellowships. If you are accepted as a full-time NYU Steinhardt Ph.D. student without an alternate funding source, you are eligible for our generous funding package, which includes a scholarship and tuition remission.

University of British Columbia, Ph.D. in Food Science (Vancouver, BC, Canada): All full-time students who begin a UBC-Vancouver Ph.D. program in September 2018 or later will be provided with a funding package of at least \$18,000 for each of the first four years of their Ph.D.. The funding package may consist of any combination of internal or external awards, teaching-related work, research assistantships, and graduate academic assistantships.

University of Michigan, Ph.D. in Nutritional Sciences (Ann Arbor, MI): All students admitted to one of our doctoral programs are considered for financial support. There are four types of financial support that we offer our students: Graduate Student Instructor (GSI), Graduate Student Research Assistant (GSRA), Training Grants and Fellowships. Many of our students are offered funding through these opportunities.

University of North Carolina Greensboro, Ph.D. in Nutrition (Greensboro, NC): Many full-time graduate students are supported by research assistantships. The standard stipends for the 9-month academic year are approximately \$16,150 for 1st year doctoral students. These assistantships require 20 hours of service per week. Also, some assistantships are available during the summer. Merit-base and minority-presence fellowships and scholarships are available during the academic year.

University of Saskatchewan, Ph.D. in Food Science (Saskatoon, SK): Students accepted into the M.Sc. and Ph.D. programs receive financial support from their supervisor's research funds. Students are also able to apply for academic awards and funds to support the student experience. In addition to potential funding from your department, there are scholarships and awards available to all eligible students.

University of Utah College of Health, Ph.D. in Nutrition and Integrative Physiology (Salt Lake City, Utah): The Department of Nutrition and Integrative Physiology offers financial assistance to most students through the award of Teaching (TA) and Research (RA) Assistantships. These positions provide financial assistance to graduate students in exchange for teaching/research and/or service related work for the department. A full assistantship provides a tuition waiver and a stipend paid throughout the academic year; these are usually reserved for doctoral students.

Fully Funded Ph.D. Programs in Pharmacology

Duke University (Durham, NC): Graduate positions in the program are fully funded providing for payment of tuition, fees, and an annual stipend for the first two years. After the first two years, students are supported by the faculty member with whom they are doing their thesis research.

University of Buffalo (Buffalo, NY): The university provides Ph.D. candidates with full support to focus on research including a full-tuition scholarship, a \$27,000 stipend and medical/dental insurance.

University of California Los Angeles (Los Angeles, CA): Departmental graduate students are supported entirely through research and training grants, which provide an annual stipend that is adjusted yearly as students advance. In addition to the stipend, the department pays full tuition, fees and health insurance.

University of Minnesota (Minneapolis, MN): All students in the Ph.D. program hold research assistantships and receive a stipend that is paid during their graduate training. Fellowships also cover education and living expenses.

University of Pennsylvania (Philadelphia, PA): All students maintaining satisfactory academic progress receive financial support until they have completed all Ph.D. requirements. This includes a twelve-month stipend plus tuition, fees, and health insurance. The amount of the stipend, which varies from year to year, will be \$34,000 in the 2019-2020 fiscal year.

University of Southern California (Los Angeles, CA): Accepted students are funded through institutional funds, faculty support and graduate assistantships including full tuition remission, a stipend and health insurance.

University of Toronto (Toronto, Ontario, Canada): Ph.D. students receive tuition, a stipend of \$20,000 and coverage of incidental fees.

Yale University, School of Medicine (New Haven, CT): Students accepted for admission normally receive full tuition plus a 12-month stipend. The basic stipend of \$35,150 is provided by the Medical School and the Department of Pharmacology.

Fully Funded Ph.D. Programs in Philosophy

Boston College (Chestnut Hill, MA): The department normally can admit five new students to the doctoral program each year. Their studies are fully funded, by tuition remission and stipends (graduate assistantships and teaching fellowships), for five years.

Columbia University (New York, NY): There is a system of multi-year financial aid packages. Such funding is awarded, as far as possible, to all incoming Ph.D. students regardless of nationality. The packages typically cover five years. All fellowship awards cover the entire cost of tuition as well as health insurance and access to the Columbia Student Health Service. In addition, they provide an annual nine-month fellowship stipend.

Duquesne University (Pittsburgh, PA): Students admitted to the Ph.D. program receive an assistantship renewable for five years. Ph.D. assistantships include stipends and full tuition waivers. For the 2018-19 academic year, the stipend is \$18,000.

Florida State University (Tallahassee, FL): In recent years, all admitted students on both the MA track and the Ph.D. track have been fully funded. Funding includes a tuition waiver and a stipend, as well as payment of the health insurance premium.

Harvard University (Cambridge, MA): Beyond tuition remission Ph.D. students normally receive financial support from the Graduate School. They receive a full stipend for four years and after the first two years have an option for teaching. The Philosophy Department gives each graduate student up to \$5,000 for research.

University of Alberta (Edmonton, Canada): Ph.D. applicants are not normally admitted without a funding commitment for the expected duration of the program (subject to satisfactory progress). Most graduate students are fully funded. Funding comes in several forms, most commonly as teaching or research assistantships. All graduate applicants are automatically considered for departmental assistantships.

University of British Columbia (Vancouver, Canada): Financial support is contingent on maintaining high academic standing and progress toward their degree completion. A typical Ph.D. student will have four years of fellowship funding and a teaching assistantship. A Ph.D. student can expect approximately \$30,000 per year.

University of Calgary (Calgary, Canada): Ph.D. students and thesis-based MA students are typically admitted with a funding guarantee. Financial support comes in the form of teaching assistantships and research scholarships; advanced Ph.D. students may also be hired to teach their own courses.

University of Chicago (Chicago, IL): Ph.D. students who matriculate in summer 2020 and after will be guaranteed to have funding support from the University of Chicago, external sources, or a combination of the two for the duration of their program to include full tuition coverage, an annual stipend, and health insurance.

University of Colorado Boulder (Boulder, CO): The Department provides significant financial support for all students in the Ph.D. program. Typically, Ph.D. students serve as Teaching Assistants (TAs) and Research Assistants (RAs). For the 2018-19 academic year, TAs and RAs earned an annual stipend of about \$21,500.

University of New Mexico (Albuquerque, NM): The UNM Department of Philosophy provides five years of full financial support which may be pro-rated for students who have already completed some graduate work in philosophy. The support may be in the form either of a Philosophy Teaching Assistantship or an English TA-ship. TA-ships carry a stipend of at least \$15,600 (2010-2011 academic year) and a tuition waiver.

University of Toronto (Toronto, Canada): Every full-time graduate student we admit is guaranteed financial support for the prescribed duration of the program. This support fully covers tuition, fees, health insurance, includes funds for living expenses and also travel funding. Average funding is about \$26,000, with the possibility of further income in the form of additional teaching assistantships and summer instructorships.

Fully Funded Ph.D. Programs in Physics

Arizona State University (Tempe, AZ): All full-time students in the Ph.D. program are guaranteed financial support in the form of a teaching assistantship or a research assistantship. These appointments include a full tuition waiver, individual student health insurance and a compensatory stipend of \$7,815.50 during the fall and spring semesters.

University of Chicago (Chicago, IL): Doctoral students are offered competitive funding packages, which cover tuition and student health insurance, as well as a stipend for living expenses and research support. These awards are typically for five years, with some variation by field, comparable to that at other institutions.

Institute of Science and Technology (Klosterneuburg, Austria): All Ph.D. students are fully funded, at internationally competitive salary levels, and receive full social security coverage. There is also additional funding to attend conferences and workshops.

Massachusetts Institute of Technology (Cambridge, MA): Graduate students are supported through a variety of sources including: Research Assistantships, Teaching Assistantships, and fellowships. All forms of support include tuition, stipend, and student health insurance.

Northwestern University (Evanston, IL): First-year students are typically supported by 12-month fellowships, which gives them great flexibility in choosing their research specialty. After the first year, students are funded as Teaching Assistants or Research Assistants which include full tuition, health insurance and a stipend.

Ohio State University (Columbus, OH): All regular incoming graduate students in Physics are offered financial support. Once accepted into a graduate program in physics at OSU, you will be awarded one of three types of graduate appointments: a teaching associate position, research associate position, or fellowship. With any of these appointments, you will receive a monthly stipend plus a full waiver of tuition and general fees.

University of Pennsylvania (Philadelphia, PA): The department attempts to support all students during the course of their work for the Ph.D. Most graduate students in Physics and Astronomy receive financial aid in the form of research, teaching, or non-service fellowships. The financial support includes both full tuition and an annual stipend.

University of St Andrews (St Andrews, Scotland): Fully funded scholarships are available for students in all research areas of the school and last the duration of the degree. Studentships are also available to national and international students, and all awards include full payment of fees and a living stipend.

Fully Funded Ph.D. Programs in Political Science

George Washington University (Washington, D.C): Funding is guaranteed for five years, conditional on adequate progress.

Massachusettes Institute of Technology (Cambridge, MA): Our aim is to fund all incoming Ph.D. students. Funding is based on merit not need. The funding package is for 5 consecutive years with full tuition, health insurance and a 9-month stipend, provided students remain in good academic standing.

New York University (New York, NY): All incoming Ph.D. students are fully funded. NYU offers all incoming Ph.D. students MacCracken fellowships that guarantee five years of support (tuition and a fellowship stipend). Additionally, the department views teaching as a vital part of the doctoral degree. Students who choose to participate in our teaching program are compensated for each teaching opportunity into which they enter. This compensation is separate and in addition to the MacCracken award outlined above.

University of Minnesota (Minneapolis, MN): All students admitted to the graduate program are guaranteed five years of financial support through fellowships, research and teaching assistantships, or graduate instructorships. Continued financial support is contingent upon timely and satisfactory progress in the program.

Stanford University (Stanford, CA): The standard financial package offered to admitted students covers the full cost of tuition and an additional amount for living expenses during the academic year. The latter amount comes in the form of a stipend during the first year and a combination of teaching and research assistantships during years 2-5. The Department also provides students with annual funds for professional development, health insurance fees, and a living stipend for the first two summers. The Department provides five years of support for Ph.D. students who are making sufficient progress towards degree.

University of North Carolina – Chapel Hill (Chapel Hill, NC): Most students in the Department of Political Science are supported by fellowships and assistantships provided by the Graduate School at UNC. These awards require service duties that range from ten to fifteen hours per week during the nine-month academic year. Such duties may be teaching in an elementary course, conducting recitation sections, or assisting a faculty member in research/teaching. After the first year, graduate students must demonstrate the ability to teach in English in order to be eligible for further financial support.

Vanderbilt University (Nashville, TN): Ph.D. students can generally expect to receive teaching/research assistantships that pay all or part of tuition, medical insurance, and a supplemental income stipend ranging from \$14,000 to \$30,000 per year for five years.

University of Notre Dame (Notre Dame, IN): Our guaranteed support, tuition plus fellowship, lasts for five full years to Ph.D. students who are making satisfactory progress toward the degree.

Washington University in St. Louis (St. Louis, MO): Our incoming classes are fully funded, covering tuition and living expenses. We try to provide financial support for our students during most if not all of their time at Washington University.

Fully Funded Ph.D. Programs in Psychology

Columbia University (New York, NY): All students accepted to the five-year program receive a fellowship, which supports tuition, health and insurance fees, and an annual stipend through the fifth year, provided that they maintain good academic standing.

New York University (New York, NY): All admitted Ph.D. students are guaranteed 5 years of funding (4 years for those with a Master's degree). The award package typically includes a full tuition scholarship, comprehensive health insurance and a stipend.

Northwestern University (Evanston, IL): All admitted Ph.D. students receive full funding, including tuition and a stipend, for 5 academic years and 4 summers.

Harvard University (Cambridge, MA): All admitted Ph.D. students are provided with fellowship packages with up to 6 years of tuition, 3 years of 10-month support, 4 summers of research fellowships, and the guarantee of a Teaching Fellowship for the 3rd and 4th years. Depending on their advisor's funds, students may also be supported as a Research Assistant in addition to, or as an alternative to, a Teaching Fellowship.

University of Liverpool (Liverpool, United Kingdom): Available to EU citizens only, the Doctorate in Clinical Psychology is a 3-year full-time programme fully funded by the National Health Service (NHS). Trainees are registered postgraduate students in the Faculty of Health and Life Sciences and employed within Mersey Care NHS Trust.

University of Maryland (College Park, MD): All admitted Ph.D. students are given assistance in the form of a fellowship or graduate assistantship for the first 5 years, which includes tuition remission of up to 10 credits per semester.

Rutgers University (Piscataway, NJ): All admitted Ph.D. students are guaranteed 5 years of funding (3 years for those with a Master's degree), provided they remain in good standing. Financial aid covers tuition and includes a 10-month stipend or salary. Additional summer funding is available through teaching or grant funding.

University of Vermont (Burlington, VT): The Department of Psychological Science attempts to fund all of its eligible full-time graduate students for at least 5 years, and has successfully since the inception of the Ph.D. program in 1965.

Fully Funded Ph.D. Programs in Public Health

Brown University (Providence, RI): All students admitted to the Ph.D. program receive funding in the form of a fellowship, teaching assistantship, traineeship, or research assistantship. The funding package includes tuition, health insurance, health services fee, and an annual stipend of \$32,533.

Columbia University (New York, NY): All Ph.D. students receive full tuition, a stipend, and health insurance coverage. The amount of the stipend is set by Columbia University. Support is provided throughout the entire five years the student is in the program.

Georgia State University (Atlanta, GA): All admitted, doctoral students who plan to study full-time will be considered for Graduate Research Assistantships (GRAs) and/or Graduate Teaching Assistantships (GTAs). Assistantships cover the cost of tuition and provide an annual stipend of \$22,000 for at least three years.

Harvard University (Cambridge, MA): All admitted students to the Ph.D. Program in Biological Sciences in Public Health, including international students, are guaranteed full funding, which includes a stipend, as well as tuition and health insurance.

Indiana University - Purdue University Indianapolis, Richard M. Fairbanks School of Public Health (Indianapolis, IN): For full-time students only, the program will typically provide funding support in the form of tuition remission, a stipend to cover living expenses, and health insurance. This support typically requires a 20 hour per week work assignment.

Johns Hopkins University (Baltimore, MD): All Ph.D. students receive full financial support, which covers tuition, fees, medical insurance and a stipend for living expenses. Graduate students are not required to serve as teaching assistants, although opportunities to teach are available if a student so desires.

McGill University (Montreal, Quebec, Canada): The Department, jointly with the Ph.D. student, offers an annual funding package valued at a minimum of \$25,000 CAD, plus tuition and fees for a maximum of four years.

New York University (New York, NY): The College of Global Public Health offers doctoral students financial support designed to help you undertake full-time study and research, to participate in superior academic and scholarly experiences, and to complete your studies in a timely manner. Average stipend amount of \$27,000 per academic year.

Pennsylvania State University (University Park, PA): The majority of graduate students entering our Ph.D. program receive funding through teaching assistantships. Others receive funding through research assistantships or through graduate school, training grants, or external programs.

Queen's University (Kingston, Ontario, Canada): Funding for Ph.D. students comes from a variety of sources, including Queen's University, research and teaching assistantships, and external studentships.

Stanford University (Stanford, CA): Though circumstances may be different from one student to another, we anticipate being able to provide and/or help students obtain financial support for the 4 years of the program. Full funding to Stanford graduate students from all disciplines, including the Ph.D. in Health Policy, is also available through the Knight- Hennessy Scholars program. Average stipend amount of \$38,736 per academic year.

Simon Fraser University (Burnaby, B.C., Canada): The Faculty of Health Sciences (FHS) is committed to providing minimum financial support, in the form of a stipend, to all Ph.D. Students. This stipend may consist of Graduate Fellowships (GF), Teaching Assistant (TA) positions, supervisor-funded Research Assistant (RA) positions and/or other scholarships/ fellowships/awards subject to availability. Average stipend amount of \$21,000 CAD per academic year.

Temple University (Philadelphia, PA): Full-time Ph.D. students generally receive financial support through a combination of university fellowships and assistantships.

University of British Columbia (Vancouver, B.C., Canada): All new full-time admissions to the SPPH Ph.D. program starting in 2018 will receive an offer of admission from the program that includes a minimum funding commitment of \$18,000 per year for four years. The funding package may consist of any combination of external or internal scholarships, research assistantships, teaching assistantships, or income from other academically-related work at UBC

University of Chicago (Chicago, IL): The Department of Public Health Sciences offers academically-qualified applicants full support including tuition, fees and a stipend. Such assistance is guaranteed through the student's first five years of study, conditional on satisfactory degree progress. Average stipend amount of \$29,500 per academic year.

University of Michigan, School of Public Health, Health Services Organization and Policy (H.S.O.P.) Program (Ann Arbor, MI): Funding directly through the H.S.O.P. doctoral program is available, and there are also many funding opportunities for Ph.D. students with the Rackham Graduate School and throughout the university. The majority of our Ph.D. students have one (or more) of these funding packages, and nearly all of our students have full funding throughout the course of their Ph.D. career.

University of Minnesota (Minneapolis, MN): All Ph.D. students are offered full funding, which includes a stipend, tuition, and health benefits. Funding comes as part of graduate research and teaching assistantships, and fellowships. NIH-sponsored traineeships are also available on a competitive basis for students who are U.S. citizens or permanent residents.

University of Pittsburgh (Pittsburgh, PA): Many Pitt Public Health doctoral students and some master's students receive some type of financial aid in the form of student loans, full or partial scholarships, fellowships, student hourly jobs, or assistantships. While funding is not guaranteed for every student, Pitt Public Health provided more than \$5 million in financial aid last year.

University of Toronto (Toronto, Canada): The University of Toronto has committed to a guaranteed minimum level of financial support to all its eligible, full-time doctoral stream students in the funded cohort, equivalent to \$15,000 per year plus tuition for the first 5 years of study.

University of Washington (Seattle, WA): Students in the Ph.D. program are offered up to five years of guaranteed funding, contingent upon satisfactory academic progress and job performance. This financial support is offered through student employment in the form of research assistantships (RA) and teaching assistantships (TA). RA and TA appointments pay a monthly stipend as well as cover the student's tuition and health insurance.

University of Waterloo (Waterloo, Ontario, Canada): All full-time Ph.D. students (domestic and international) are guaranteed a minimum of \$22,400/year for four years. Funding normally comes in the form of a Teaching Assistantship (TA), Research Assistantship (RA), or major award.

Vanderbilt University (Nashville, TN): All students offered admission to the doctoral program receive a full tuition scholarship, stipend, health insurance and coverage of fees. Average stipend amount of \$29,500 per academic year.

Yale University (New Haven, CT): All admitted Ph.D. students are guaranteed four years of 12-month stipend and tuition support. In addition to grants and fellowships for tuition and living costs, students receive a Health Award, which covers the full cost of single-student Yale Health Plan Hospitalization/Specialty Coverage.

York University (Toronto, Ontario, Canada): To provide a vibrant and diverse educational experience, the overall funding package available to our graduate students is key to their success. Over the past year, we have developed a new funding model that offers eligible full-time domestic and international graduate students consistent funds throughout the academic year. Average stipend amount \$17,506 CAD per academic year for domestic students.

Fully Funded Ph.D. Programs in Public Policy and Public Administration

Carnegie Mellon University, Heinz College (Pittsburgh, PA): The financial aid program for the Ph.D. in Public Policy and Management is designed to provide students with the financial support necessary to enable them to successfully complete the program. This support also allows the student to gain classroom experience that is valued in the academic marketplace. Every Ph.D. student in good standing receives a full-tuition scholarship for their entire tenure in the program. Students who remain in good standing may also receive a stipend and Teaching Assistantships of up to \$27,000 per academic year.

Duke University, Sanford School of Public Policy (Durham, NC): During the first year of the program, most students receive a scholarship for tuition and fees and are paid a stipend via departmental or external fellowships, with no additional work obligations. In years two and three, students are expected to work as Research or Teaching Assistants to earn part of the stipend. In years four and five, students will be funded through a combination of research assistantships and external dissertation fellowships.

Georgia State, Andrew Young School of Policy Studies/Georgia Tech (Atlanta, GA): The Andrew Young School has been able to fund virtually all full-time students for at least three years. Assistantships typically provide full tuition waivers and stipends of \$18,000 per year. Three new doctoral students each year receive Andrew Young or AYSPS Dean's Scholar Fellowships, which provide an additional \$6,000 annually.

Pardee RAND Graduate School (Santa Monica, CA): Pardee RAND's program enables students to cover their tuition while receiving a consistent stipend for living expenses each year. Funding the Ph.D. is achieved through a combination of a generous scholarship and a research fellowship earned by working on RAND projects of the student's choice.

Princeton University, Woodrow Wilson School of Public and International Affairs (Princeton, NJ): The doctoral program offers full merit-based funding to cover the cost of each student's tuition and living expenses for five years. The stipend for living expenses is \$30,975.

University of Michigan, Gerald R. Ford School of Public Policy (Ann Arbor, MI): At present, new doctoral students enter our program with a funding package sufficient to cover tuition, insurance, and living expenses for the first five years of study.

University of Southern California (USC), Sol Price School of Public Policy (Los Angeles, CA): Incoming Ph.D. students at USC are fully supported for four years through a graduate assistantship that provides tuition remission, a stipend for fall and spring semesters, year-round health and dental insurance, and payment of the university's health center fee for fall and spring semester. The graduate assistantship provides an opportunity for students to work on teaching and collaborative research with one of our faculty members. Students beyond their fourth year of study are often supported through teaching assistantships, research assistantships or a combination of funding sources from USC and/or outside sources.

University of Washington, Evans School of Public Policy & Governance (Seattle, WA): The University of Washington Evans School typically provides a 5-year graduate assistantship for entering students. All funding packages include full tuition remission and a competitive stipend for living expenses during the academic year. A variety of additional internal fellowship and funding opportunities exist for students, including excellent travel support for attending professional conferences, and summer income assisting faculty on externally funded research projects.

Fully Funded Ph.D. Programs in Religion and Theology

Boston University (Boston, MA): All students admitted to the Doctor of Philosophy program are awarded full tuition fellowships plus a generous stipend for the first five years of study. The Federal Direct Stafford/Ford Loan program is also open to students in the Doctor of Philosophy program.

Brown University (Providence, RI): Our students receive five years of full funding; additional funding is possible but not guaranteed.

Duke University (Durham, NC): Currently, our program is set up to pay fellowships on a 9-month basis for the first 5 years. Summer funding is guaranteed in summers 1 and 2 of the program. Students who no longer have guaranteed summer funding are encouraged to apply for competitive funding both internally and externally. All students must have proof of health care, and the program is prepared to cover the cost of up to 6 years of health insurance if needed.

Fordham University (New York, NY): In 2009, the Fordham University Theology Department began offering Ph.D. students full funding for their doctoral studies. As part of the Graduate Teaching Assistantship (GTA) program, every second-year Ph.D. student will have an opportunity to work with at least one faculty member in a Fordham undergraduate classroom prior to teaching on his or her own in the third year.

Northwestern University (Evanston, IL): Northwestern University provides all graduate students in the humanities with the same standard package of guaranteed funding. Currently, this includes the following: five academic years of tuition and stipend, five summers of study stipend, health insurance and a U-pass for public transportation.

Stanford University (Stanford, CA): All Religious Studies Ph.D. students receive five years of funding, which includes fellowship stipends or teaching assistantships, and tuition for the academic year. In addition, students receive three funded summers of support.

University of Notre Dame (Notre Dame, IN): Full-time students in good standing are eligible to receive a 12-month annual stipend (an amount of \$23,000 for students starting in 2018-2019) for up to five years and a full-tuition scholarship for up to eight years.

University of Pennsylvania (Philadelphia, PA): The typical doctoral program in Religious Studies is funded over a five-year period, over which students are expected to engage in coursework, complete teaching assistantships, and attend the graduate colloquium. Requirements for the program include a minimum of two languages, qualifying examinations, preliminary examinations (with an oral examination component), and an oral dissertation defense.

Wheaton College (Wheaton, IL): We offer a full tuition scholarship, as well as a research fellowship, for each of the six students accepted per year to enable each student to devote himself or herself to advanced learning as a fully involved member of the academic community.

Fully Funded Ph.D. Programs in School Psychology

Howard University, School of Education (Washington, DC): Fellowships and assistantships are available for graduate students, full fellowship for an academic year is remission of tuition and a \$20,000 stipend.

Louisiana State University, Department of Psychology (Baton Rouge, LA): Graduate students are supported through departmental assistantships and outside funding providing a stipend (approximately \$15,050/year) along with a full tuition waiver.

Michigan State University, Department of Counseling, Educational Psychology & Special Education (East Lansing, MI): The graduate school offers fellowship packages worth approximately \$100,000 in tuition, stipend, assistantships, and insurance over four years.

Pennsylvania State University, College of Education (Center County, PA): Fellowships and assistantships are available for Ph.D. students to provide a stipend and remission of tuition and fees.

University of Florida, College of Education (Gainesville, FL): Ph.D. students are supported through fellowships and teaching assistantships including tuition payment and stipends.

University of Minnesota, College of Education and Human Development (Minneapolis, MN): 100% of students are fully funded through fellowships and student assistantships which include tuition payment, stipends and health insurance.

University of Northern Colorado, Department of School Psychology (Greeley, CO): Teaching and research assistantships, as well as fellowships, are available offering tuition waivers and stipends.

Tulane University, Department of Psychology (New Orleans, LA): Full-time teaching assistantships are available to the majority of entering students for the first five years of study. A full teaching assistantship involves teaching duties of 12-15 hours per week. Such a position includes full tuition remission and a modest stipend. Stipends for 2015-2016 were \$19,00 for 9 months.

Fully Funded Ph.D. Programs in Social Work

Boston College (Boston, MA): Most students at the Boston College School of Social Work receive a four-year financial aid package worth more than \$125,000. These fellowships provide a living stipend plus tuition remission. Boston College also awards a diversity fellowship each year that provides an additional year of support.

Michigan State University, School of Social Work (East Lansing, MI): The School is pleased to offer five years of guaranteed, graduate assistantship funding to all qualified incoming students. During the first four years, students will receive a graduate assistantship (GA); during the fifth year, students will not receive a guaranteed GA, but instead will receive an award of \$10,000.

New York University (New York, NY) Accepted full-time students are typically awarded the Dean's Fellowship, which includes full tuition and registration fee waivers, graduate student health insurance, and a competitive stipend. Part-time students may be eligible for some support on a case-by-case basis.

University of Alabama (Tuscaloosa, AL): Students admitted to the Ph.D. program are guaranteed 2 years of funding, and lately all students have received 3-4 years of funding. Funding involves tuition and a stipend of about \$1,500 per month.

University of Michigan (Ann Arbor, MI): The Joint Program in Social Work and Social Science provides all incoming doctoral students with a multi-year funding package. We combine fellowship awards, graduate student research assistant positions, and graduate student instructorships to offer most students five years of full funding, which includes tuition, stipends, and health care.

University of Pittsburgh (Pittsburgh, PA): Our full time program is highly competitive and we accept 6-8 students each year. The students we accept are fully funded with tuition and stipend support for four years of study.

University of Southern California (Los Angeles, CA): All incoming students accepted and admitted into the program and who remain in good academic standing will receive financial assistance for the first four years, amounting to \$200,000.

Fully Funded Ph.D. Programs in Sociology

Brown University (Providence, RI): The Graduate School currently provides five years of funding to students in good standing. Funding usually consists of a mix of fellowship, TA, and RA appointments.

Cornell University (Ithaca, NY): Cornell funding packages typically offer five years of support, covering all tuition and providing a stipend for living expenses (including during the summer). In recent years, the field has been able to support students beyond their fifth year, usually through grant-funded graduate research assistantships.

Harvard University (Cambridge, MA): For Ph.D. students, Harvard awards full financial support for five years, typically for the first four years of study as well as the completion year.

New York University (New York, NY): The NYU Department of Sociology only accepts students whom we can fully fund for a minimum of five years. The funding generally covers full tuition, fees, student health insurance plus a fellowship stipend. In addition, students have the opportunity to teach. Teaching is separate from the funding package, and any teaching compensation is above and beyond the fellowship support.

Rice University (Houston, TX): Students accepted into the Ph.D. program will be fully funded. In addition to tuition waivers, each student will receive a generous stipend. Some will be eligible for summer funding as well.

Stanford University (Stanford, CA): The department offers a standard package, consisting of a stipend and the payment of tuition and fees, to incoming students. Both domestic and international students are eligible for this standard package. Although the Department cannot formally guarantee support beyond the first year, it expects to continue to provide an additional four years of support to students making satisfactory academic progress. This assistance normally covers the full cost of tuition and an additional amount for living expenses during the academic year. The latter amount is usually in the form of a stipend, teaching assistantship, or research assistantship.

University of Chicago (Chicago, IL): The University of Chicago offers most doctoral students competitive funding packages, which cover tuition and student health insurance, as well as a stipend for living expenses and research support. These awards are typically for five years.

University of Toronto (Toronto, Canada): The Faculty of Arts and Science has instituted a funding guarantee that covers Ph.D. students for four or five years (depending on whether the student enters directly from a BA, or completes an MA before entering the program). The guarantee is equal to tuition plus \$17,500. The guarantee is met by a balance of three components: the U of T Fellowship, Teaching Assistantships, and Research Assistantships.

University of Washington (Seattle, WA): Automatic consideration for all applicants in both admission AND financial support. As a matter of departmental policy, admitted students are typically offered a multi-year funding package as part of their offer of admission. The vast majority of our students are funded throughout their time in graduate school, with a mix of teaching positions, research assistantships, and fellowships.

Vanderbilt University, Department of Sociology (Nashville, TN): All students admitted to the Ph.D. program are offered funding, which includes a 12-month stipend, full tuition waiver, and student health insurance. If students continue to make good progress in the program, funding typically continues for five years. Outstanding applicants may also be eligible for departmental, College of Arts and Science, or University fellowships that supplement the standard stipend.

Yale University, Department of Sociology (New Haven, CT): All accepted students are fully funded for five years. In the first four years they receive full tuition and a living stipend and in the fifth or sixth year students are eligible for the dissertation write-up fellowship. In the third and fourth years students are required to serve as teaching fellows to receive their stipend.

Fully Funded Ph.D. Programs in Statistics

Columbia University, Ph.D. in Statistics (New York, NY): All students in the Ph.D. program receive, for up to five years, a funding package consisting of tuition, fees, and a stipend. These fellowships are awarded in recognition of academic achievement and in expectation of scholarly success; they are contingent upon the student remaining in good academic standing. Summer support, while not guaranteed, is generally provided.

Ohio State University, Ph.D. in Statistics (Columbus, OH): Students who are offered funding at the time of admission either via a Fellowship or Graduate Teaching Associateship are typically guaranteed funding through the duration of their program (up to five years if needed for a Ph.D. student or two years for a master's student) provided that the student continues to make appropriate progress toward the degree and carries out assigned duties satisfactorily.

Stanford University, Ph.D. in Statistics (Stanford, CA): Students accepted to the Ph.D. program are offered financial support. All tuition expenses are paid and there is a fixed monthly stipend determined to be sufficient to pay living expenses. Financial support can be continued for five years, department resources permitting, for students in good standing.

University of Chicago, Ph.D. in Statistics (Chicago, IL): In recent years our department has been able to provide full support (tuition, most fees, health insurance, and a stipend) for most of its Ph.D. students, and we expect to do so for the foreseeable future. Ordinarily, students are supported for at least four years. Support is not tied to working with a particular faculty member. At present, most fifth-year students receive full support, and most Ph.D. students receive summer support.

University of Nevada, Reno, Ph.D. in Statistics and Data Science (Reno, NV): All students accepted to the Statistics and Data Science Ph.D. program receive an annual stipend of \$17,000, a tuition waiver and a subsidized medical plan. Students may also pursue departmental and University-wide scholarships.

University of Texas at Austin, Ph.D. in Statistics (Austin, TX): It is our intention that each Ph.D. Statistics student will be fully financially supported for four academic years, the duration of his/her program of study. There are in general three types of support: academic employment, graduate fellowships, and grants.

University of Texas at San Antonio, Ph.D. in Applied Statistics (San Antonio, TX): Full-time students admitted to the Ph.D. program are usually awarded fellowships that include a waiver of tuition, a stipend to help cover living expenses, and some health care benefits.

Duke University, Ph.D. in Statistical Science (Durham, NC): The Graduate School provides a competitive package that provides Ph.D. students with financial support for at least a majority of the time they are registered and working toward their degree. This support includes four main components: a stipend, tuition coverage, fees coverage, and coverage of health insurance premiums.



Fully Funded Master's Programs

University-sponsored full funding packages for candidates at the master's level are much less common than those offered at the doctoral level. This is because most Master's degrees are only one to two years in length and most degrees are professionally oriented, rather than research-based. To identify universities offering full funding at the master's level, I suggest narrowing your search to universities where master's students are eligible for Graduate Assistantships (also called Studentships and Instructorships).

In this Directory, we were able to compile full funding awards for master's programs in Business (MBA), History, English, Fine Art (MFA), Public Policy (MPP), Public Administration (MPA) and International Affairs, and more. This Directory is not an exhaustive list of fully funded master's programs - there may be others in your field of interest!

There are also several full funding awards sponsored by foundations, non-profits, government agencies and corporations that can provide full funding for a master's degree. These awards are nationally, and in some cases, internationally competitive.

Full Funding Awards for a Master of Biology

East Carolina University (Greenville, NC): Graduate Teaching Assistantships are available for students in the thesis-based MS degree programs. The Graduate Teaching Assistantship is currently funded at \$10,000 for the academic year and is intended to help defray the costs of living and of attending the University. A minimum of \$2,500 of additional support is also available from a variety of funding sources for the summer period.

Loyola University (Chicago, IL): Most students in the MS in Biology degree program receive funding. The Graduate School awards several stipends and tuition scholarships to qualifying students. The stipend for 2010–2011 is \$16,000 per year for a maximum of two years with a full-tuition scholarship for 30 credit hours. Fully-funded students will also receive Health Insurance for two years.

Memorial University (Newfoundland and Labrador, Canada): Memorial University offers competitive funding packages to academically eligible full-time graduate students, both Canadian and international, in all eligible research programs. Funding: MSc: \$17,500. Some international graduate students may be eligible for external funding.

Smith College (Northampton, MA): The Biological Sciences Master's Program is fully funded: accepted students receive a tuition waiver and an academic year stipend in exchange for work in the department as a teaching fellow assisting with laboratory courses. Students are also eligible for summer stipends and research support.

The College of William and Mary (Williamsburg, VA): Most of our graduate students are funded by a teaching assistantship. Students who pursue an MS degree receive summer support from their advisors' grant funds and, for those holding a teaching assistantship, from W&M. Other financial aid to students may involve faculty grants or part-time employment on an hourly basis in the department.

University of Alabama at Birmingham (Birmingham, AL): Stipends and Fellowships are available for qualified graduate students from a variety of sources, both federal and local. The Department of Biology awards Graduate Teaching Assistants (GTAs) to qualified students, providing an initial annual stipend of \$18,000 (MS) as well as student health insurance and tuition remuneration.

University of Florida (Gainesville, FL): The Department will provide teaching assistantships to all students who do not receive fellowship support or research assistantships for the expected duration of the program, assuming the student continues to make timely and satisfactory progress in the program. Assistantships over the 9-month academic year come with stipends of \$12,600 – \$18,000 plus a tuition waiver and health insurance.

University of San Francisco (San Francisco, CA): Students admitted to the program are fully funded, including a full scholarship and a salary earned through teaching or research assistantships. Most graduate students are awarded a teaching assistantship with a stipend of \$7,200 per year.

University of Southern Mississippi (Hattiesburg, MS): Prospective graduate students are eligible for teaching assistantships, which carry an academic year stipend and can expect a summer stipend yielding annual support of \$12,000 and \$16,000, respectively. Grant-supported research assistantships carry at least comparable support. It includes a tuition waiver and health insurance.

Western Michigan University (Kalamazoo MI): Most MS students are funded through teaching assistantships, which cover tuition and an academic-year stipend.

Full Funding Awards for a Master of Business Administration (MBA)

The Forté Fellows Program by the Forté Foundation offers fellowships to women who are pursuing a full-time, part-time or executive MBA education at participating business schools. If you would like to be considered for a fellowship, you must submit an MBA application to a participating school. Each school makes the determination of where the Forté awards will be given. All schools grant awards for full-time students, but part-time and executive awards are only available at select schools.

The Fulbright/Instituto de Empresa Grants (Madrid, Spain) are full grants with tuition waivers that are co-sponsored by the Instituto de Empresa Foundation. One award is available to pursue an International MBA at the Instituto de Empresa (IE) Business School in Madrid, one of the world's leading business schools. One award is available to pursue a full-time Master in International Management at IE. There is also a grant for the IE School of Communication and is appropriate for recent graduates and young professionals with 2 to 3 years of experience in the field of Communication. Applicants must apply for admission to both Fulbright and the IE program in question.

Cornell University's Johnson School of Business Roy H. Park Leadership Fellows Program (Ithaca, NY) is a two-year full-tuition fellowship award for up to 25 Johnson students who have demonstrated outstanding leadership potential. In addition to their MBA curriculum, Park Fellows participate in a robust leadership development program. Features include: a cohort of 25 learning partners for developing leadership skills; a two-year developmental sequence based on the development of personal, interpersonal, team and system mastery skills; a constant cycle of experiential learning and reflection; a track record of leadership performance that is made through contributions to the school and surrounding community. Must be a US citizen to apply.

Full Funding Awards for a Master of Chemistry

Michigan Technological University (Houghton, MI): Teaching Assistantships and Research Assistantships are offered to qualified applicants. A typical GTA and GRA package includes tuition, fees, and a stipend. Stipends are adjusted periodically to ensure that they are competitive.

University of Denver (Denver, CO): Graduate students receive full tuition and a nine-month stipend as they pursue master's or Ph.D. degrees in chemistry and biochemistry, working as either graduate research assistants (GRAs) or graduate teaching assistants (GTAs).

University of Ottawa (Ottawa, ON, Canada): Graduate students are paid while they work toward their graduate degree through scholarships, stipends and/or teaching assistantships. For non-scholarship holders once accepted into our M.Sc. we guarantee a minimum total stipend of \$21,000 per year, for at least 2 years for a M.Sc. To receive this stipend, you will act as a teaching assistant (TA).

University of San Francisco (San Francisco, CA): Students admitted to the program are funded, including a full graduate scholarship, and most earn a salary earned through teaching or research assistantships.

University of Saskatchewan (Saskatoon, SK): All eligible students will be guaranteed a stipend that may come from multiple funding sources such as research grants, scholarships, or teaching assistantships. In 2019/2020 M.Sc. students will receive a minimum of \$23,000.

University of Toronto (Toronto, ON): The Graduate Department of Chemistry provides a base funding for students in the funded cohort provided they maintain satisfactory progress toward completion of their degree. Stipends are a combination of teaching assistantship, research assistantship, external scholarships and/or University of Toronto Fellowship support. For 2021-22, the A&S base funding package will be \$19,000.

University of Wyoming (Laramie, Wyo): All students admitted to the University of Wyoming's Department of Chemistry are fully funded through Graduate Teaching and Graduate Research Assistantships. Students receive an annual stipend of \$25,500 total a year, a full tuition and fee waiver, and medical insurance.

Full Funding Awards for a Master of History

Auburn University (Auburn University, AL): Financial aid is available to a select number of graduate students in the form of Graduate Teaching Assistantships, which carry a tuition waiver and stipend. All graduate applicants are eligible to apply for assistantships.

Georgia State University (Atlanta, GA): Graduate Research Assistantships (GRAs), with an annual stipend, are available for award to M.A. students. GRAs typically work with a faculty member as a research assistant for ten hours a week during the academic year.

Miami University of Ohio (Oxford, OH): Normally, each student may be supported with a departmental Graduate Assistantship for a maximum of two years. All applicants for admission to the full-time M.A. program in History are considered for assistantships. The History Department Graduate Assistantships pay a stipend and include a remission of university instructional fees for the regular school year.

Ohio State University (Columbus, OH): The History Department's general policy has been to provide an M.A. student with a maximum of four semesters of support. The History Department awards graduate teaching assistantships that carry stipends and tuition waivers.

Texas Tech University (Lubbock, TX): The Department of History awards Teaching Assistantships annually. The stipends currently range from \$13,000 to \$15,000, and include in-state tuition status as well as the waiver of some fees.

University of Mississippi (University, MS): The department offers several graduate assistantships every year; each pays as much as \$12,000 per year and automatically includes a tuition scholarship. The assistantships are competitive and based on merit, and all applicants to our program are automatically considered for these assistantships.

University of Oregon (Eugene, OR): The major form of funding for newly admitted graduate students is the Graduate Employee (GE) award. GEs are awarded on a competitive basis to both M.A. and Ph.D. students, based on academic merit, without regard to financial need. Each GE award includes a tuition waiver, a stipend, and health insurance benefits.

University of South Carolina (Columbia, SC): The History Department supports a limited number of Public History students through graduate assistantships. These can be teaching assistantships or professional assistantships. Assistantships, whether teaching or professional, usually require a commitment of 15-20 hours/week and pay a stipend that ranges up to \$7,625/semester. Students who hold assistantships automatically qualify for the in-state rate of graduate tuition and receive a tuition abatement.

Washington State University (Pullman, WA): Students may hold teaching assistantships for a maximum of 2 years while enrolled in the M.A. program and 4 years if enrolled in the Ph.D. program. Research assistantships and other graduate appointments are exempt from these financial assistance guidelines.

Full Funding Awards for a Master of English

Florida State University (Tallahassee, FL): The majority of students in the Graduate English Program receive support in the form of a teaching assistantship. Teaching assistants are provided with a stipend and a waiver for most of their tuition. Experienced TAs are often invited to teach during the summer term for an additional stipend.

James Madison University (Harrisonburg, Virginia): Full-time students receive full tuition remission and a living stipend, and students gain valuable experience both as teaching assistants and in allied academic roles.

Oregon State University (Corvallis, OR): All students admitted to the MA in English program will automatically receive a standard Graduate Teaching Assistantship contract, which provides full tuition remission and stipend of approximately \$12,300 per year to cover living expenses.

University of Alabama (Tuscaloosa, AL): Students admitted to the graduate program are guaranteed up to five years of full financial support (up to four years for the MFA; up to two years for the MA). All admitted students qualify for Graduate Assistantships, which include a stipend paid over nine months (currently \$14,125), and full payment of up to 15 credit hours of graduate tuition.

University of Kentucky (Lexington, KY): MA Students are offered teaching assistantships in the Department of Writing, Rhetoric, and Digital Studies (WRD) for a stipend plus full tuition remission and student health insurance.

University of Idaho (Moscow, ID): Our graduate students are offered teaching assistantships, all of which are fully funded. TA's receive in-state and out-of-state waivers, teach a 2-1 course load, and receive substantial instructional support from our Director of First-Year Composition and staff.

University of Louisville (Louisville, KY): The department awards up to 10 Graduate Teaching Assistantships to our top M.A. applicants each year. M.A.GTAships run 10 months and offer tuition remission, insurance, and a stipend.

University of Maine (Orono, ME): We award twenty-one teaching assistantships each fall, with approximately half of these usually assigned to new students. Recipients teach one section of first-year composition each semester; they receive stipends of approximately \$15,600 (Fall 2019) for the nine-month school year as well as tuition remission for each semester and for two summers (6 credits) while enrolled in the program.

University of Mississippi (Oxford, MS): Unlike many Masters programs, which are oriented primarily toward tuition-paying students, the English Department at the University of Mississippi offers a funded Master's degree, enabling us to attract qualified applicants regardless of means.

University of Wyoming (Laramie, WY): All full-time students admitted to the program receive full funding, including free tuition, teaching opportunities, and a generous living stipend.

Virginia Commonwealth University (Richmond, VA): Select students in the MA graduate programs are funded by Graduate Assistantships available through the Department of English. These are awarded on a competitive basis and are generally renewable for up to two years.

West Virginia University (Morgantown, WV): Every student admitted to the M.A. program is guaranteed funding for two academic years, the customary time to degree, as a Graduate Teaching Assistant (G.T.A.). This position includes an annual salary of \$16,000, a waiver of university tuition, and student health insurance.

Full Funding Awards for a Master of Fine Art

MFA in Writing

Boston University, MFA in Creative Writing (Boston, MA): Tuition costs will be covered for every admitted student in the program. In addition, students will receive university health insurance while they are enrolled and all admitted students will receive stipend support.

Cornell University, MFA in Creative Writing (Ithaca, NY): Our small size allows us to offer a generous financial support package that fully funds every student.

University of California Irvine, MFA in Writing (Irvine, CA): The Department of English provides three full years of financial support to all domestic students in the MFA Programs in Writing. Support is given through teaching assistantships which include full tuition coverage as well as University health insurance (medical, dental, and vision).

University of California Riverside, MFA in Creative Writing and Writing for the Performing Arts (Riverside, CA): All incoming students are granted a full fellowship and stipend for their first year. After the first year, students receive full tuition and a salary through teaching assistantships.

University of Iowa, MFA in Writing (Iowa City, IA): Financial assistance is available for all students enrolled in the program, in the form of teaching assistantships, research assistantships, and fellowships. Most fellowships and assistantships provide either tuition scholarships or full tuition remission.

University of South Carolina, MFA In Creative Writing (Columbia, SC): The MFA at Carolina is pleased to provide fellowship and/or assistantship funding to all accepted students.

MFA in Art

Illinois State University, MFA in Art (Normal, IL): The University provides graduate assistantships as a means of financial support. Monthly wages paid in the form of either a stipend or an hourly wage, waiver for 100% of tuition during a semester of appointment, a waiver for up to 12 credit hours of tuition for the summer term immediately following a fall or spring appointment are included.

Ohio State University, MFA in Visual Art (Columbus, OH): Most students accepted into the MFA Program are funded with a Graduate Associate appointment, which requires working 20 hours a week in exchange for a fee authorization (payment of tuition) and a stipend. These appointments may include teaching introductory courses, assisting in department labs, and working for The Arts Initiative.

Stanford University, MFA in Art Practice (Stanford, CA): Through a combination of fellowship funds and teaching assistantships, each Art Practice graduate student normally receives an aid package that includes tuition and stipend as well as small materials grants.

Tulane University, MFA in Studio Art (New Orleans, LA): All admitted graduate students receive a full tuition waiver and a generous assistantship stipend.

University of Arkansas, MFA in Studio Art (Fayetteville, AR): All students in the M.F.A. Studio Art program are fully supported. We are able to provide full assistantships to all of our M.F.A.'s. The assistantship includes a full tuition waiver and a stipend that will increase next year to \$15,000 annually, plus a Graduate Fellowship in the amount of \$4,000 per year, for a total package of \$19,000 of support per year

University of California, Davis, MFA in Art Studio (Davis, CA): The Art Studio MFA Program offers substantial financial support through paid Teaching Assistant positions each quarter and through Art Studio Program Fellowships, made possible by generous private endowments.

University of Connecticut, MFA in Studio Art (Storrs, CT): Fully funded program providing both tuition remission, stipend, and health insurance.

University of Georgia, MFA in Art (Athens, GA): All students in the MFA and Ph.D. programs are fully funded. Assistantships are renewed on an annual basis. Funding is also available from various sources to offset the cost of materials and travel related to graduate research.

University of Michigan, MFA in Art & Design (Ann Arbor, MI): The Stamps School offers generous financial support to graduate students, in addition to teaching and research assistantships, stipends, and discretionary funds.

University of South Florida, MFA in Studio Art (Tampa, FL): Every current graduate student in the School of Art & Art History receives a full tuition waiver plus either a scholarship OR a graduate assistantship. The USF School of Art & Art History offers two graduate degree programs: Master of Arts in Art History and Master of Fine Arts in Studio Art.

Full Funding Awards for a Master of Philosophy

Colorado State University (Fort Collins, CO): Each year, the department offers 6-7 graduate teaching assistantships to incoming graduate students. These funding packages cover tuition, health insurance, and a monthly stipend.

Florida State University (Tallahassee, FL): In recent years, all admitted students on both the M.A. track and the Ph.D. track have been fully funded. Funding includes a tuition waiver and a stipend, as well as payment of the health insurance premium.

Georgia State University (Atlanta, GA): The Department offers a funding package to every graduate student it admits to the M.A. program. Every funding package includes subsidized health insurance and a full waiver of tuition (which in 2016-17 was \$4,680/semester for Georgia residents and \$15,012/semester for out-of-state residents). Students must still pay fees, about \$1,000/semester.

Indiana University (Indianapolis, IN): A limited number of graduate assistantships are available for new or returning students each academic year. Each assistantship includes a \$9,000 stipend, health & dental insurance, and a waiver of most tuition fees.

Kent State University (Kent, OH): A limited number of graduate assistantships (with competitive stipends) and tuition/fee waivers are available for graduate students. In the past, most students have received financial aid. During 2018–19, the total financial aid award per student is approximately \$25,500, which includes a \$12,500 stipend, a full tuition waiver worth \$12,000, a health insurance subsidy (for students who do not otherwise have coverage), and workers compensation.

Miami University (Oxford, OH): A limited number of graduate assistantships are available on a competitive basis. These carry a work expectation of approximately 15-20 hours per week assisting a faculty member. In 2014-2015, assistantships were \$13,000 plus remission of tuition costs.

Texas State University (San Marcos, TX): There are a limited number of Instructional Assistant (IA) positions for full-time students (9 hours per semester). IAs typically assist the instructor of record in the large sections of Philosophy & Critical Reasoning and Ethics & Society. These positions pay enough to cover tuition, fees, and some living expenses. Given satisfactory performance, IA positions are usually renewed.

Texas Tech University (Lubbock, TX): Teaching Assistantships are provided to almost all students admitted to the program. The philosophy department typically awards 9 or 10 Teaching Assistantships each year. Stipends are commensurate with duties. The standard TA stipend is \$13,000.

University of Arkansas (Fayetteville, AR): Departmental teaching assistantships are available. For 2019-2020 the stipend was \$12,400, plus tuition waiver. Graduate assistants usually teach Introduction to Philosophy, Introduction to Ethics, or Logic.

University of Mississippi (Oxford, MS): Each year we award four, two-year Teaching Assistantships to incoming graduate students. These feature a 100% tuition waiver and an annual stipend of \$10,000. One of the incoming TA's is eligible for a Graduate Honors Fellowship and receives a \$12,000 annual stipend.

University of Toledo (Toledo, OH): Almost all full-time students in the program are given a Teaching Assistantship (funded at competitive levels) and a full tuition fellowship. Moreover, many students are invited to teach their own courses in their third or fourth semesters.

University of Wisconsin-Milwaukee (Milwaukee, WI): A number of graduate teaching assistantships are available, offering full tuition remission and salaries of approximately \$9,075. Normally, provided they make adequate progress toward the degree, students who enter with graduate teaching assistantships will have them for the full two years.

Full Funding Awards for a Master of Psychology

Brock University (Ontario, Canada): Funding is guaranteed for two years, approx. \$17,500 per year. There are external scholarships and awards through provincial and national award agencies which can significantly boost funding per year.

College of William and Mary (Williamsburg, Virginia): Every student in the Psychological Sciences graduate program receives a teaching or research assistantship. These assistantships carry a full remission of tuition costs and a nine-month stipend.

University of Colorado (Colorado Springs, CO): M.A. students are funded in a variety of ways, including departmental funding of Federal work-study awards, serving as a departmental Teaching Assistant, and other positions within the department. Additionally, some M.A. students are funded as a Research Assistant in their research mentor's lab.

University of British Columbia (Vancouver, BC, Canada): Support is available to both domestic and international graduate students and consists of some combination of fellowships, awards, teaching assistantship, and research assistantship. Students receive a minimum guaranteed level of support for the first two years of the MA (\$23,000 per year for two years).

Western University (Ontario, Canada): The Department of Psychology offers generous funding packages which currently exceed the cost of tuition. Graduate students in Psychology at Western are offered guaranteed funding for 2 years of Master's. \$25,874 CDN/year for domestic students and \$36,874 CDN/year for international students.

Full Funding Awards for a Master of Public Policy (MPP), Master of Public Administration (MPA) or Master of International Affairs (MIA)

Duke University Master of Public Policy (Durham, NC): The Master of Public Policy Program at Duke University Sanford School of Public Policy provides merit-based scholarships to all accepted MPP applicants who are not receiving full funding from outside sources. Sanford issues merit-based awards to our domestic and international students in the form of tuition scholarships and/or teaching, research or staff assistantships. US citizens are also guaranteed assistantships for two academic years of study, conditional upon satisfactory coursework progress during the first year. International students may apply to positions that remain open.

City University of New York's Bernard M. Baruch College, National Urban Fellows Program (New York, NY): The National Urban Fellows' Master of Public Administration Fellowship is a rigorous, 14-month, full-time graduate degree program comprising two semesters of academic coursework and a nine-month mentorship assignment. Fellows receive a \$25,000 stipend, health insurance, a book allowance, relocation and travel reimbursement, and full payment of tuition, in addition to their ongoing personal and professional development. The program culminates in a Master of Public Administration (MPA) degree from the City University of New York's Bernard M. Baruch College, School of Public Affairs.

Princeton University Woodrow Wilson School (Princeton, NJ): The Woodrow Wilson School at Princeton University offers a one-year Master of Public Policy (MPP) degree for mid-career professionals who are rising leaders in international and domestic public policy. The School also offers a Master of Public Affairs (MPA). The Wilson School aims to enable graduate students to earn a graduate degree without incurring debt, thereby making it more feasible to pursue careers of public service in the public and nonprofit sectors. Unless applicants receive outside scholarships from governmental or other funding agencies, the School will offer each candidate a full scholarship for tuition and a need-based stipend to cover living expenses. Stipends are offered on the basis of each individual and family.

Tsinghua University, Schwarzman Scholars Program (English language program in Beijing, China): Schwarzman Scholars is a highly selective, one-year master's program at Tsinghua University in Beijing, China. Whether in politics, business or science, the success of future leaders around the world will depend upon an understanding of China's role in global trends. Students will live and study together on the campus of Schwarzman College, a newly-built, state-of-the-art facility, where all classes will be taught in English. Students can pursue a degree in Public Policy, Economics and Business, or International Studies. Schwarzman Scholars receive tuition and a stipend, room and board, RT travel, and an in-country study tour.

Robertson Foundation for Government Fellowships fully fund master's degrees in international relations, policy, and related fields at select U.S. partner universities. Individuals interested in a fellowship may apply to one or more of RFG's partner schools. Applicants must be U.S. citizens and have functional fluency in a foreign language (or attain by graduation). Fellows agree to the fellowship requirement to work for the federal government for a minimum of three of the first seven years after graduation. Contact the individual schools for more information on their application and selection processes and deadlines to pursue a fellowship.

University of Maryland School of Public Policy, TIAA Nonprofit Leadership Fellows Program at the Do Good Institute (College Park, MD): The TIAA Nonprofit Leadership Fellows program is focused on providing professional development opportunities to students who wish to pursue careers in the nonprofit field. Fellowships support master's students as they complete their degree and include: 2 years of tuition, health benefits, mentoring, training and paid internships.

Fulbright-Anne Wexler Master's Awards in Public Policy (Australia and the United States): This award enables Australian and U.S. postgraduate students with strong academic credentials and leadership potential to undertake a two year Master's degree in Australia or the U.S. focusing on public policy. These may include key areas such as health, sustainability, energy, climate change, regional security, education, political science, history or governmental relations. The award includes tuition, a living stipend and travel. Two Fulbright Anne Wexler Scholarships will be awarded annually: one for an Australian citizen and one for an American (US) citizen.

Harvard University's Zuckerman Fellows Program (Cambridge, MA): This program equips people from the fields of medicine, law, and business to provide leadership for the common good by making it possible for them to pursue public service degrees at the Harvard Graduate School of Education, Harvard School of Public Health, or Harvard Kennedy School. The Zuckerman Fellowship provides recipients with full tuition and health insurance fees plus a stipend of \$17,000 for one year. In addition to their formal coursework, Zuckerman Fellows participate in a yearlong co-curricular program that includes small-group discussions, professional skill-building workshops, and a field trip.

Harvard University Kennedy School's Gleitsman Fellowship (Cambridge, MA): This fellowship sponsors Harvard Kennedy School students who are emerging social activists and innovators who are interested in pursuing a career with a transformative impact on society. Gleitsman Fellows will participate in an enriching co-curricular experience designed to enhance their skills and engage their development as the next generation of public leaders. The fellowship is for 2 years and includes tuition and health fees as well as leadership training co-curricular courses. Open to domestic and international applicants entering their first year at Harvard Kennedy School.

Harvard University Kennedy School's Dubin Fellows Program for Emerging Leaders (Cambridge, MA): This award is for entering master's degree students at Harvard Kennedy School who have demonstrated strong character, academic excellence, the ability to thrive and lead in the face of adversity, and a commitment to making a transformative impact on the communities they serve. Fellows are awarded tuition and health fees for up to 2 years while studying their master's and summer stipends are available to pursue summer internships or leadership development courses. Open to domestic and international students entering their first year at HKS.

Harvard University Kennedy School's Sheila C. Johnson Leadership Fellowship (Cambridge, MA): This award brings together diverse and talented emerging leaders based on their demonstrated leadership promise and demonstrated interest in reducing disparities in African-American communities through efforts in health care, education, economic development, public policy, criminal justice reform, social entrepreneurship, and a variety of other fields. Fellows are awarded a full tuition scholarship and health fees and are eligible for a stipend up to \$10K. This fellowship is open to applicants entering their first year of study in any of the Harvard Kennedy School's masters' degree programs.

Harvard University Kennedy School's U.S. Latino Leadership Fellowship (Cambridge, MA): This award is a game-changing opportunity for practitioners, scholars, and activists ready to lead the transformation of U.S. Latino and other underserved communities. The fellowship aims to create sustainable changes and innovative ideas to revolutionize local and national policies toward these communities while also giving the fellow networking opportunities and leadership training. The fellowship is open to all Harvard Kennedy School graduate degree programs and includes full tuition, health insurance and a \$25K/year stipend for the duration of the degree.

George Mason University's Mercatus MA Fellowship (Fairfax, VA): This fellowship is a two-year, competitive, full-time fellowship program for students pursuing a master's degree in economics at George Mason University who are interested in gaining an advanced degree in applied economics in preparation for a career in public policy. Students who anticipate working in public policy—as researchers, policy analysts, journalists, etc.—are ideal candidates for this fellowship. The total award of up to \$80,000 (over two years) includes a monthly stipend, full tuition support (nine credits per semester), and practical experience conducting and disseminating research with Mercatus scholars and staff on pertinent policy issues.

Multidisciplinary Full Funding Awards for a Master's Degree

Awards for U.S. Programs

The Donald M. Payne International Development Graduate Fellowship Program encourages the application of members of minority groups who have historically been underrepresented in international development careers and those with financial need. The Payne Fellowship Program provides benefits valued at up to \$93,000 over two years toward a two-year master's degree, arranges internships in Washington D.C. and at USAID missions overseas, and provides professional development and support. Applicants must be college seniors or graduates looking to start graduate school in the fall of the year they apply, have GPAs of at least 3.2 and be U.S. citizens.

The Thomas R. Pickering Foreign Affairs Graduate Fellowships are supported by the U.S. Department of State and administered by the Woodrow Wilson National Fellowship Foundation. The Pickering Fellowships provide funding to graduate students as they prepare to join the U.S. Foreign Service as diplomats. Fellows are funded \$37,500 per year to help cover tuition costs first then room and board, books, mandatory fees and travel, pending availability of funds. Graduate-level Fellows receive stipends during participation in one 10-week domestic summer internship, and one 10-week summer overseas internship following the second year of graduate school.

The Charles B. Rangel International Affairs Fellowship Program provides full funding awards for those interested in a career in the U.S. Foreign Service. The fellowship includes benefits of up to \$95,000 over two years toward a two-year master's degree, arranges internships on Capitol Hill and at U.S. embassies, and provides mentorship and professional development support. Fellows can use the fellowship to attend two-year master's programs in U.S. institutions to study any area of relevance to the Foreign Service. Applicants must be college seniors or graduates looking to start two-year graduate programs in the fall, must have GPAs of at least 3.2, and must be U.S. citizens.

Paul and Daisy Soros Fellowships for New Americans honor immigrant tradition in the U.S. by providing up to \$90,000 over 2 years to 30 new Americans who will be pursuing a full time graduate degree program in any field at an American institution in the United States. To be eligible, you must be 30 or younger, and either have been born in the U.S. to two immigrant parents or have been born outside the U.S. (as a non-citizen) and, as of November 1 of the year you apply, be a DACA recipient, naturalized citizen or in possession of a green card (i.e., be a resident alien). They will also be opening the requirements to all immigrants who graduated from high school and college in the US.

The Fulbright Foreign Student Grant Program enables graduate students, young professionals and artists from abroad to study and conduct research in the United States. The Fulbright Foreign Student Program operates in more than 155 countries worldwide. Program eligibility and selection procedures vary widely by country. Please visit the website to find information about the Fulbright Program in your home country, including eligibility requirements and application guidelines.

Harvard University's Frank Knox Memorial Fellowships are awarded each year for students from Canada, Australia, New Zealand and the United Kingdom for graduate study at Harvard University. A Knox Fellowship pays full Harvard tuition and mandatory health insurance fees and provides a stipend sufficient to cover the living expenses of a single Fellow for a 10-month academic year. Each Knox Fellowship applicant must also submit an application for admission directly to the Harvard graduate or professional school of his/her choice. Each country has a different deadline – check website.

Stanford University's Knight-Hennessy Scholars Fellowship (Stanford, CA) program offers up to one hundred, fully-funded graduate degree programs including the DMA, JD, MA, MBA, MD, MFA, MS and Ph.D. degrees as well as joint- and dual-degrees. Scholars will receive a living and academic stipend to live within the Stanford graduate community at the Denning House, which is dedicated to interaction with each other and distinguished visitors. Eligible applicants can be from any country, while holding at least the equivalent of a U.S. bachelor's degree. After the application materials have been obtained, there will be a candidate immersion weekend for 200 applicants to determine the accepted fellows.

The AVANGRID Scholarships for Master's Studies in the United States are open to students of U.S. nationality to pursue masters-level work with an emphasis on sustainable energy, energy efficiency and climate-related areas of study, in addition to more specific business areas, such as cybersecurity, data science and engineering. The scholarship will cover the following annual tuition at the university or college in the U.S., and annual program allowance of \$25,200 during the academic year to cover costs for accommodations and transportation (where applicable).

Civil Society Leadership Awards (CSLA) provides fully-funded scholarships for master's degree study to international students who clearly demonstrate academic and professional excellence and a deep commitment to leading positive social change in their communities. Competition for the CSLAs is open and merit-based. Selection is based on an applicant's fit with the program's objectives as well as the graduate admissions criteria of the participating universities. Applicants must demonstrate a clear commitment to return to their home country or region to continue supporting open society development.

The CyberCorps Scholarship For Service (SFS) is a unique program designed to increase and strengthen the cadre of federal information assurance professionals that protect the government's critical information infrastructure. This program provides scholarships that may fully fund the typical costs of full-time students while attending a participating institution, including tuition and education and related fees. Additionally, Fellows receive stipends of up to \$20,000 for undergraduate students and \$32,000 for master's and doctoral students. The scholarships are funded through grants awarded by the National Science Foundation (NSF).

The GEM MS in Engineering Fellowship Program aims to increase the number of underrepresented minority students (African Americans, American Indians, and Hispanic Americans) pursuing graduate degrees in engineering and natural science and to promote the benefits of a graduate degree within industry. GEM MS Engineering Fellows receive a \$4,000 living stipend per full-time semester up to 4 semesters, up to two paid summer internships with a GEM Employer Member and full tuition and fees provided by a GEM University Member. Applicants must be a U.S. citizen or U.S. permanent resident.

The Science, Mathematics And Research for Transformation (SMART) Scholarship for Service Program is an opportunity for students pursuing an undergraduate, graduate or doctoral degree in Science, Technology, Engineering, and Mathematics (STEM) disciplines to receive a full scholarship and be gainfully employed upon degree completion at the U.S. Department of Defense. Include full tuition and a stipend of \$25K – \$38K, and other benefits. Undergraduate applicants must be currently enrolled in a U.S. college or university. Graduate applicants can be either currently enrolled in a U.S. university or awaiting notification of admission.

The Tillman Scholars Program unites and empowers remarkable military veterans and spouses as the next generation of private and public sector leaders committed to service beyond self. The premier fellowship supports Tillman Scholars with annual funding for academic expenses, including tuition, books and living expenses, a national network, and professional development opportunities. Fellows are empowered to make an impact in the fields of medicine, law, business, policy, technology, education and the arts. Active duty service members, veterans, and military spouses are eligible for the fellowship which covers academic expenses, including tuition and fees, books and living expenses.

The Trinity Fellows Program at Marquette University is a graduate fellowship dedicated to developing urban leaders with a commitment to social and economic justice. Fellows participate in a 21-month study/work program while earning a master's degree in one of 15 disciplines. Eligible applicants must meet the admissions requirements of the Marquette University Graduate School. In addition, applicants must have completed a full-time service program, such as Peace Corps, Jesuit Volunteer Corps, AmeriCorps, or other comparable programs, OR have worked 2+ years full-time in a nonprofit organization. The fellowship includes a full-tuition scholarship and a monthly stipend.

New York University's World Journalist Fellowship provides international journalists with funding to study at one of the master's programs at NYU's Arthur L. Carter Journalism Institute. The Fellowship covers tuition and fees for two of the three semesters of the journalism graduate program, as well as a stipend of \$13,000 for each of the two semesters. The fellowship is open to international journalists with at least two years of experience at a journalism publication and fluency in English and at least one other language. Journalists interested in the Fellowship must initiate an application to the M.A. program at NYU's Arthur L. Carter Journalism Institute.

The Foreign Affairs Information Technology (FAIT) Fellowship is an opportunity for students to pursue an IT-related degree and launch a career in the U.S. Foreign Service as an Information Management Specialist. Fellows receive up to \$37,500 annually for their junior and senior years in an IT-related undergrad program, or for a two-year master's program. These funds are applied toward tuition, room and board, books, mandatory fees, and some travel expenses. Plus, you'll receive stipends, housing and travel allowances for the two summer internship experiences. Applicants must be a U.S. citizen and enrolled in an undergraduate program relevant to Information Technology and entering the junior year OR seeking admission in an IT-related master's degree program, at a U.S.-based accredited institution.

Awards for International Programs

A Fulbright U.S. Student Grant for Study/Research allows provides funding for graduate study or for individually designed study/research projects that will take place during one or more academic years in a country outside the U.S. Applicants design their own projects and will typically work with advisers at foreign universities or other institutes of higher education. The study/research awards are available in approximately 140 countries. For recent BA/BS graduates, graduate and doctoral students, and young professionals including artists, musicians, writers, journalists, and those in law, business, and other professional fields. Undergraduate and graduate students must apply through their institution; professionals and former students can apply through their alma mater or At Large.

Marshall Scholarships finance young Americans of high ability to study for a graduate degree in the United Kingdom. Up to forty Scholars are selected each year to study at graduate level at a UK institution in any field of study. To be eligible, candidates must be U.S. citizens and have obtained a grade point average of not less than 3.7 (or A-) on their undergraduate degree. Apply through your university and check with your university for internal deadlines.

The Rhodes Scholarships are postgraduate awards supporting outstanding all-round students at the University of Oxford, and providing transformative opportunities for young leaders. Established in 1903 under the will of Cecil Rhodes, the Rhodes is the oldest and perhaps the most prestigious international graduate scholarship program in the world. A class of 83 Scholars is selected each year. Please review the website for country-specific citizenship, age and academic eligibility requirements and deadlines.

Chevening Scholarships offer a unique opportunity for future leaders, influencers, and decision-makers from all over the world to develop professionally and academically, network extensively, experience UK culture, and build lasting positive relationships with the UK. The programme provides full or part funding for full-time courses at postgraduate level, normally a one-year Master's degree at any UK University. To be eligible for a Chevening Award you must be a citizen of a Chevening-eligible country; return to your country of citizenship for a minimum of two years after your award has ended; and apply to three different eligible UK university courses.

The Anna Sobol Levy Foundation Fellowships provides funding to U.S. citizens who are college graduates to pursue a master's degree in English at the prestigious IDC Herzliya's Raphael Recanati International School, located near Tel Aviv. The Fellowship covers tuition at the IDC (up to \$16,000). Levy Fellows must enroll in one of the IDC's security-related MA programs: (1) counter-terrorism and homeland security, or (2) diplomacy and conflict studies. Candidates must be U.S. citizens under age 30 at the time application and should have studied in the fields of military studies, economic geography, international relations, political science, history, or similar fields.

The London School of Economics' Atlantic Residential Fellowship supports applicants in taking the one year MSc Inequalities and Social Science (MISS), with dedicated mentorship, as well as engaging with the wider work of the Atlantic Fellows programme. The Fellowship includes all tuition fees, a stipend to cover living costs whilst in London, and expenses for attendance at Atlantic Fellows events. Applicants must meet the conditions of the MSc Inequalities and Social Science at LSE.

The High North Fellowship program offers scholarships to students from Canada, Japan, Russia, South Korea and the U.S. who attend an institution in Northern Norway as part of their higher education. The program is funded by the Ministry of Foreign Affairs. Each fellowship recipient receives a monthly stipend and a travel grant of the same amount. Institutions of higher education in Norway do not charge tuition from international students, and the stipend is intended to cover housing and living expenses. The program is mainly targeted at students at the Master's and Bachelor's level, but is also open to Ph.D. students.

The Rotary Peace Fellowship annually selects up to 100 individuals from around the world to receive fully funded academic fellowships at one of our peace centers in Australia, England, Japan, Sweden and the U.S. These fellowships cover tuition and fees, room and board, and RT transportation. Two types of fellowships are available: (1) 15-24 month master's degree fellowships at premier universities in fields related to peace and conflict prevention and resolution and (2) 3-month fellowships for experienced professionals working in peace-related fields at Chulalongkorn University in Thailand. For more information, contact your local Rotary club or the Rotary Peace Centers Department at The Rotary Foundation.

American University in Cairo's TEFL Fellowships, in teaching English as a foreign language (TEFL), are offered annually to full-time students who wish to pursue a master's degree in TEFL and to acquire language teaching experience at The American University in Cairo. Fellowships are offered in the Department of English Language Instruction for two academic years and the intervening summer session. The award includes a waiver of tuition fees, monthly stipend, accommodation and one-way home travel. Fellows pursue degree study and teach eight hours of English per week.

Cambridge University's Winston Churchill Scholarship Program enables young Americans to pursue graduate study in science, mathematics, and engineering at Churchill College, Cambridge University. A total of 15 one-year Churchill Scholarships are offered each year. The scholarship covers living expenses in addition to tuition and fees. Candidates must be US citizens who have earned a bachelor's degree but not a doctorate. Applicants must be nominated by their undergraduate institution. The Churchill Foundation's deadline is in mid-November. Each college may have earlier deadlines.

Peking University's Yenching Academy Scholarship provides a generous graduate scholarship that covers tuition fees, a travel stipend for one round-trip journey between each Scholar's base city and Beijing, accommodations, and living costs on Peking University's campus. This specially designed, English-taught program aims to push the study of China beyond the boundaries of traditionally defined Humanities and Social Sciences disciplines. Students from around the world are invited to apply and can choose between many different fields to base their thesis on including law, economics, international relations, philosophy, literature and history.

Gates Cambridge Scholarships are awarded to outstanding applicants from outside the UK to pursue a postgraduate degree in any subject at the University of Cambridge. They are awarded on: intellectual ability, leadership capacity, a commitment to improving the lives of others, and a good academic fit between the applicant's aspirations and abilities and the course at Cambridge for which they are applying. There are two application deadlines: mid-October (US citizens normally resident in the USA) and early December (all other candidates).

#1 Sign up for ProFellow.com. Create a free account at ProFellow to search our fellowships database listing more than 1,300 funding opportunities for professional and academic endeavors. With an account, you can bookmark fellowships to your profile. Be sure to join our mailing list so you can be alerted about newly added fellowships, upcoming deadlines and open calls for applications.

#2 Search for fully funded graduate programs through Google. Use search phrases that include the degree, discipline and keywords such as "full funding" and Assistantships to identify programs. For example, for a fully funded degree in agricultural sustainability, you could Google: *Ph.D. agriculture "full funding"*. As another example you could Google: *Master's agriculture Assistantships*. Please see my video on "How to Find Fully Funded PhD Programs Using Google."

#3 Contact Admissions. Many universities do not put information about their funding options for master's and doctoral students on their website. Make a shortlist of your top choice programs and carefully research funding options for students in that program by contacting Admissions for more information.

#4 Enroll in Fully Funded, my new course and mentorship program for graduate school applicants.
